This is an anticipatory bail petition filed on behalf of petitioner, namely, Idrish Ansari, who is apprehending his arrest in connection with Motihari Cyber P.S. Case No. 101 of 2025 U/S 318(4), 319(2), 338, 336(3), 340(2), 303(2) of Bharatiya Nyaya Sanhita, 2023 and 66(C), 66(D) of I.T. Act.

**In para-2 of the anticipatory bail petition, it is mentioned that no other anticipatory or regular bail petition has ever been filed on behalf of the petitioner either in this Court or before the Hon'ble High Court, Patna. In para-3 of the anticipatory bail petition, this petitioner has no criminal antecedent.**

As per F.I.R., on 24.07.2024, the informant Arsad Ali received an overseas job advertisement on Instagram from an account named "izhaan immigration." After contacting the account, the accused persons Sadam Hussain, Faizan Ansari @ Munna Ansari and Irdish Ansari (petitioner) induced him and his friends to visit their office at Dum Dum, Kolkata, and promised to send them abroad for employment under a scheme requiring rupees 10 lakh per person. Believing their representation, the informant and three others deposited Rs. 21,75,000/- in the bank account of accused Sadam Hussain bearing no.923010066975956. The accused later sent overseas job related documents through speed post. However, on verification at the Delhi Embassy on 28.02.2025, the documents were found to be forged. When the informant visited the Kolkata office, it was found closed and the accused had absconded. Upon tracing them to their residence at Rudrapur, Uttarak-

hand, and demanding refund, the accused allegedly assaulted, abused, and threatened him with dire consequences.

The learned counsel for the petitioner has submitted that the petitioner is innocent, he has committed no offence, as alleged and has falsely been implicated in this case. The alleged date and time of occurrence petitioner was not present at the place of occurrence rather he was at this working place Kayum Khan Company where he used to do work of driving JCB and to show the same petitioner has annexing copy of relevant documents.

The learned Public Prosecutor appearing on behalf of the State has opposed the prayer for bail.

Heard both sides and perused the record. From perusal of record it transpires that the petitioner is named in the F.I.R. with the allegation that the petitioner including his associates doing forgery in the name of overseas employment with the informant. As per para-50 of the case diary, five complaint registered on the said account number in different States regarding money fraud, which details mentioned in para-51, 52, 53, 54 and 55 of the case diary. As per para-12, 13, 14 and 15 of the case diary, the informant in his restatement and the victim witnesses have supported the prosecution case. As per para-3 of the bail petition, the petitioner has no criminal antecedent. The I.O. of the case has submitted the case diary without submitting the criminal antecedents of the petitioner.

In the facts of the case as discussed above and keeping in view the nature of allegation and gravity of offence, I am not inclined to give pre-arrest bail to the petitioner. Accordingly, the prayer for anticipatory bail of petitioner **Irdish Ansari @ Irdish Ansari** stands **rejected**.

**Let a copy of this order be communicated to the Superintendent of Police, East Champaran at Motihari to take necessary action against the erring I.O., for non-submission of criminal antecedent of the accused in the case diary.**
