further submits that as per para 20 there is one criminal antecedent is pending against this petitioner i.e, Muffasil P.S. Case No. 670/2025 dated 15.10.2025 u/s 310(4), 310(6), 310(5), 317(2), 317(4), 317(5), 111, 338, 336(3), 340(2), 3(5) of B.N.S and 25(1-b), 26/35 of Arms Act. He further submits that as per para 30 where supervisory authority has found this case true against this petitioner

5. Perused the case record. On perusal of case record it transpires that the FIR has been registered against unknown. From perusal of case diary it appears that in para 2 of the re-statement of the informant is mentioned and he has supported the prosecution case. In para 3, 9, 10, the witnesses have supported the case of prosecution. In para 13 & 14 of the case diary where confessional statement of co-accused petitioner is mentioned in Muffasil P.S. case no 670/2025 where they have taken the name of this petitioner regarding involvement of alleged offence in the present case. Further from the perusal of para 20 of the case diary it also appears that there is one criminal case is pending against this petitioner i.e, Muffasil P.S. Case No. 670/2025 dated 15.10.2025 u/s 310(4), 310(6), 310(5), 317(2), 317(4), 317(5), 111, 338, 336(3), 340(2), 3(5) of B.N.S and 25(1-b), 26/35 of Arms Act. Further from the perusal of para 30 of the case diary where supervisory authority has found the case true against the petitioner and further from the perusal of entire case record it appears that chargesheet has already been submitted against this petitioner and the petitioner is in judicial custody since 24.11.2025.

6. In the facts and circumstances of the case and criminal antecedents of accused- petitioner of same nature of the case, I am not inclined to enlarge the petitioner-accused on bail. Accordingly, the prayer for bail of petitioner-accused namely **Krishna Kumar** , stands rejected.
