1. This bail petition has been filed on behalf of the aforesaid accused/petitioner, who is in custody since 05.02.2026 in connection with Garahiya Bazar P.S. Case No.- 31/2026, u/s 329(3), 126(2), 115(2), 109, 76, 303(2), 352, 3(5) of the BNS.

2. The prosecution case as per typed application of the informant Kajal Kumari given to the SHO of Garahaiya Bazar PS stating therein that on 02.02.2026 at 08.20 AM that when she sat on her darwaja then all the FIR named accused persons with petitioner came with weapons in their hands and abused the informant and Lal Kumar Sahni told by abusing that she is a woman and tried to become a tigress and teach her a good lesson and pulled her sari and outraged her modesty then Pramod Sahani with iron rod and Lal Kumar Sahani with lathi hit on the head of the informant and she sustained injury and fell down on the ground. Gyan Sahni told that do not leave her and he also dragged the informant by her hair and her clothes was opened. Meena Devi snatched Mangalsutra and ear ring of the informant. The informant became unconscious due to excess bleeding and she was taken to the hospital for the treatment and due serious condition she was referred to the Sadar Hospital Motihari, East Champaran.

3. Learned Counsel for the petitioner submitted that the petitioner is quite

innocent and has falsely been implicated in this case malafidely due to malice intention. The petitioner has one criminal antecedent Garahiya OP Madhuban PS Case No. 493/24. No other regular or anticipatory bail petition has ever been filed earlier either this Ld. Court or before Hon'ble High Court Patna. It has further been submitted that the alleged allegations are out and out false and concocted and no any material has been recovered from the possession of the petitioner. The petitioner is in custody since 05.02.2026. Accordingly, Ld. Counsel prayed to release the petitioner.

4. Learned Addl. Public Prosecutor opposed the prayer for bail.

5. Perused the record. On perusal, I find that petitioner is named accused in the FIR and the allegation against him is that he alongwith co-accused persons assaulted the informant with iron rod and there is no allegation against him. He has no criminal antecedent except one Garahiya OP Madhuban PS Case No. 493/24 . He is in custody since 05.02.2026.

Considering the facts and circumstances of the case, I am inclined to enlarge the petitioner on bail, on furnishing bail bond of Rs. 10,000/-(Ten thousands) with two sureties of the like amount each to the satisfaction of the court of learned lower court, Motihari, East Champaran.
