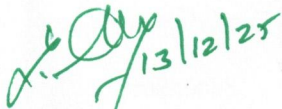
AWARD

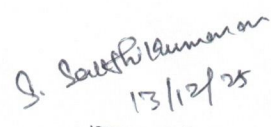
A compromise award without interest and cost for a sum of Rs. 65,000/- (Rupees Sixty Five Thousand only) payable by the 2nd Respondent Insurance Company (M/s SBI General Insurance Co. Ltd) to the Petitioner/Petitioners and directed the 2nd Respondent to deposit the above award amount in the Bank account of the HON'BLE ASJ court by way of National Electronics Funds Transfer (NEFT) /Real Time Gross Settlement (RTGS).

This Award of this Lok Adalat shall be deemed to be a decree of the Civil Court as per Section 21 of the Legal Services Authorities Act 1987.

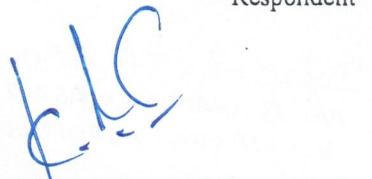
