Commitment Order:-

The above named accused is sent up by the SHO, P.S.City-I Malerkotla to face trial for the offence punishable U/s 379-B, 411 and 201 of IPC.

2. The case of the prosecution briefly stated is that 2/5/2021 ASI Nirmal Singh alongwith other police officials in connection with checking of suspected persons on private vehicle were present at main

gate of Police Station where complainant Naveen Kumar son of Raghu Kulbhushan, resident of Guru Nanak Colony, Malerkotla got recorded his statement that on 1/5/2021 at about 7:00 PM, the complainant after closing his medical shop was coming towards his house on his scootery no.PB13AC-1715 in which the bills of medical shop and Rs.40-45000/- was lying in the digi of scootery, it was about 7:15 PM. When the complainant turned towards the street of Monika Model School, Malerkotla, then three unknown persons with muffled faces were standing there, out of them one person was wearing white colour shirt, yellow turban and blue coloured pants, second person was wearing bringle colour shirt and white coloured pants and third person was wearing black coloured shirt and white coloured pants. Out of them one person was armed with thing like iron rod and gave blow of the same on the right shoulder of complainant due to which the complainant fell on the ground. Those persons were telling each other that they will take the scootery and remaining will come behind on the motor cycle. Out of those persons, one person had snatched the scootery and had taken the same with him alongwith the bills and cash lying in the scootery. After admitting the statement to true and correct, complainant put his signatures in English language. On the basis of statement of complainant, the FIR under Section 379-B of IPC was registered against the accused. Thereafter, during the investigation, offences under sections 411 and 201 of IPC were added later on. Accused were arrested. The place of occurrence was inspected. Site plan was prepared. Statements of witnesses under Section 161 Cr.P.C.

were recorded. After completion of investigation and other formalities, challan was prepared and presented in the court against accused.

3. Copies of challan and documents attached with the challan are provided to accused free of costs as required U/s 207 Cr.P.C.

4. I have heard the learned APP for the State and learned defence counsel and have also carefully perused the file. The undersigned is not competent to try this case as the offence U/s 379-B of IPC and same is exclusively triable by the learned Court of Sessions. Therefore, the case in hand, is hereby ordered to be committed to the Court of learned District & Sessions Judge, Sangrur for 18/10/2022. Accused on bail are directed to appear before the said learned Court at sharp 10:00 AM on the date fixed. Ahlmad is directed to complete the file in all respects and then to send the same to the Court of learned District & Sessions Judge, Sangrur, well before the date fixed. Prosecution Agency be informed accordingly.
