This bail application has been filed on behalf of above named accused/petitioner, who is in judicial custody since 08.02.2026 in connection with ***Wazirganj P.S. Case No. 43/2026***, for the offences registered ***U/s. 303(2), 317(2) of the I.P.C.***, pending in the Court of Ms. Varsha Kumari, Ld. J.M.F.C., Gaya.

2. Heard both the sides on the bail application.

3. Learned defence counsel submitted that prior to this case, petitioner has not filed anticipatory or regular bail petition either before this Court or the Hon'ble High Court, Patna. Ld. Defence Counsel further submitted that petitioner is innocent, committed no offence and has falsely been implicated in this case. It is further submitted that innocence of this petitioner is also evident from the hard fact that neither any signature or thumb impression is there over the alleged seizure list, making the entire search and seizure made in clandestine manner. The story of scattering the looted amount does not inspire confidence to believe upon, moreover there is no allegation or story as such that this petitioner was being chased by the public at large. Lastly he submitted that petitioner having no criminal antecedent and he is in judicial custody since 08.02.2026. Hence, prayed to grant the bail to the accused petitioner.

4. Per contra the Ld. A.P.P. appeared on behalf of State opposed the prayer for bail.

5. Prosecution case, in brief, as per informant is that on 07.02.2026 at about 03.30 PM. He kept Rs. 60,000/- in dicky of his Motorcycle and was coming to his house from the Block and at about 4.00 P.M. he reached Mali Gali and parked his motorcycle near Hanuman Medical Shop and went to take medicine. After sometime some of individuals making a noise that a person was trying to flee way after taking money from the dicky of motorcycle. The thief spreaded the money while fleeing but he was caught by the local resident. Rs. 22,000/-

was found from the pocket of thief and Rs. 20,000/- spreaded on the road. When the informant chekced the dicky of his motorcycle then he did not find his all money. Total amount of Rs. 42,000/- seized and rest amount could not be found. The apprehended person disclosed his name as Vinit Kumar.

6. Heard both the parties and perused the material available on record. From perusal of F.I.R., it appears that petitioner is named in the F.I.R. The allegation agianst the accused petitioner of stealing the money from the dicky of informant while he went to medical shop after parking his motorcycle, local people caught the accused petitioner while he was trying to flee after stealing the money and recovered Rs. 42,000/- from his possession. From perusal of seizure list, it transpires that neither signature nor thumb impression of accused petitioner has been taken on the seizure list by the police. Vide para 42 of the case diary, charge-sheet has been submitted against the accused petitioner after completion of investigation against him. Petitioner claimed to have clean antecedent vide para 03 of his bail petition. Petitioner is in judicial custody since 08.02.2026.

7. Considering the aforesaid facts and circumstances of the case and period of custody, I think, it is fit to enlarge the petitioner on bail. Accordingly, it is directed that the petitioner, above named, be released on bail on furnishing bail bonds of Rs. 10,000/- (Ten thousand) with two sureties of the like amount each, subject to the condition that:-

- (i) One of the bailors shall be a close relative of the petitioner.
- (ii) He would not involve in any case in future except this case, otherwise the prosecution will be at liberty to move for cancellation of their bail bonds.
- (iii) He will remain present physically on each and every date till framing of charge.
