ORDER

18.07.2026

This is an application for grant of Anticipatory Bail filed on behalf of the petitioners who are apprehending their arrest in connection with Muffasil P.S. Case No. 337/2026, registered u/ss 126(2), 115(2), 109, 351, 352, 3(5) of B.N.S. which is pending in the Court of Ld. C.J.M., Gaya.

As per F.I.R., allegation against the petitioners is that they assaulted the informant's son by iron rod due to which he badly injured and also threatened to kill him.

The Ld. Counsel for the petitioners submitted that no any bail application either regular or anticipatory has been filed or moved in this Court or any other Higher Court. It is further submitted that the petitioners are innocent and have been falsely implicated in this case due to dispute. Informant wants to give pressure upon these petitioners. Petitioners have no criminal antecedent. It has been further submitted that the entire allegation against the petitioners is false and concocted and prayed to enlarge the petitioners on bail.

Ld. A.P. for the State has vehemently opposed the bail of the petitioners.

Heard the Ld. counsel for the petitioners as well as Ld. A.P. for the State and perused the record. From perusal of the case record, it appears that case has been registered u/ss 126(2), 115(2), 109, 351, 352, 3(5) of B.N.S. Allegation against the petitioners is that they assaulted the informant's son by iron rod due to which he badly injured and also threatened to kill him. available which shows:- (I) Lacerated wound over left side parital region of head(size- 3cm x 0.5 cm), nature of injury is simple caused by hard and blunt object. There is counter case between the parties vide Wazirganj P.s. Case No. 400/25. As per para 3 of bail petition as well as para 29 of case diary petitioners have no criminal antecedent.

Considering the entire facts and circumstances of the case, submission of the parties material available on the record, I am inclined to enlarge the petitioners on anticipatory bail. Hence, their prayer for anticipatory bail is hereby, allowed. They are directed to be released on anticipatory bail on furnishing bail bonds of **Rs. 10,000/- (Ten Thousand)** with two sureties of the like amount each to the satisfaction of the Court below in connection with Muffasil P.S. Case No. 337/2026, subject to the conditions as laid down under section 482(2) of B.N.S.S., in the event of arrest or surrender before the Ld. Court below within four weeks from the date of receipt of this order.
