Arguments on the bail application heard. Record perused.

Having regard to the overall facts and circumstances of the case and the submissions made on behalf of parties, the accused is admitted to bail subject to furnishing bail bond in the sum of Rs. 10,000/- with one surety in the like amount.

Bail application disposed off accordingly.

Bail bond furnished and accepted.

Let notice be issued to the SHO concerned to file report as to whether any FIR u/s 209 BNS has been registered against the accused or not.

It is jointly submitted that the civil liability in the present matter along with other connected matters i.e. total 5 inspections/cases and any other unsettled inspection/case pending till today i.e. 26.02.2026 i.e. case bearing ID No. RW031019CA041 (present case); RW120221CA011; RW180725CA045; RW140126CA005; and RW301025CA017, under Multiple Case Scheme with the complainant company has been settled for a further payment of Rs. **80,000/-** which shall be paid by accused to the complainant in two EMIs of Rs.40,000/- each payable on or before 28th of each English Calendar month commencing from March 2026 **with further request to provide electricity connection subject to completion of commercial formalities.**

It is submitted by the accused that he want to plead guilty with further submission to take lenient view against him as he has already made payment of the impugned bill.

Accused is duly warned about the legal consequences of his plea of guilt and he has been informed that he may be convicted on the basis of his plea of guilt. He has been given time to think over again and to consult his counsel but he has insisted to plead guilty to

the offence committed by him.

After making necessary enquiry from the accused, the court is satisfied that the accused has voluntarily pleaded guilty to the offence committed by him.

It is prayed by accused that benefit of Probation Act may be given to him and he be released on probation.

Separate statement of AR for the complainant regarding settlement of civil liability recorded.

Separate statement of accused regarding settlement of civil liability as well as plea of guilt towards criminal liability is also recorded.

In view of the fact that the matter has been settled, let the accused be provided with new electricity connection after payment of the settlement amount and subject to completion of commercial formalities.

Let notice be issued to the SHO concerned for filing report regarding previous conviction/ involvement report of the accused and report from the concerned Probation officer be also called for the next date of hearing.

List the matter for confirmation of payment as well as report on 28.03.2026.
