**ORDER**

**18-08-2026**

A regular bail petition has been filed on behalf of the petitioner which was moved today, who is in custody since 05.05.2026 in connection with Mahkar P.S. Case No. 203/2024, registered u/ss 334(1) & 303(2) of B.N.S. which is pending in the court of Ms. Shikha Priya, Ld. J.M.F.C., Gaya Jee.

Prosecution case, in brief is that on 25.12.2024 at about 9:00 pm, the informant closed his shop situated at Nai Bazar and when he come back in the next morning to open his shop where he saw that shutter of the shop was broken and all the materials of the shop were scattered and when he entered into shop he found that T.V. Camera, Wifi and Rs. 8000/- from the locker were stolen by some unknown thieves and about total loss was of Rs. 60,000/- to the informant.

The Ld. Counsel for the petitioner submitted that the petitioner is quite innocent and has been falsely implicated in this case. Petitioner is in custody since 05.05.2026. Petitioner is also accused in 1. Mahkar P.S. Case No. 109/2025, 2. Khizersarai P.S. Case No. 207/22, Khizersarai P.S. Case No. 12/25, 4. Mahkar P.S. Case No. 18/25, 5. Mahkar P.S. Case No. 124/, 6. Mahkar P.S. Case No. 205/24, 7. Mahkar P.S. Case No. 13/25, 8. Mahkar P.S. Case No. 9/25, 9. Khizersarai P.S. Case No. 221/22. It has been further submitted that no any regular or anticipatory bail petition has been filed on behalf of the petitioner either before your honours court or any higher court. It has been further submitted that petitioner is not named in the FIR. It has been further submitted that the petitioner has been remanded in this from Mahkar P.S. Case No. 18/25 n the basis of confessional statement of co-accused Kundan Kumar and since then he is rotting in

judicial custody. It has been further submitted that there is no cogent material against the petitioner showing his involvement in the alleged crime. It has been further submitted that the entire allegation against the petitioner is false and baseless and prayed to enlarge the petitioner on bail.

The Ld. A.P.P. for the State has vehemently opposed the bail of the petitioner.

Heard the Ld. counsel for the petitioner as well as Ld. A.P.P. for the State and perused the record. From perusal of the record, it transpires that this case has been registered u/s 334(1) & 303(2) of B.N.S. against unknown persons. In this case charge sheet has been submitted u/s 334(1) & 303(2) of B.N.S. against the petitioner and other co-accused. On 18.09.2025 cognizance has also been taken u/s 334(1) & 303(2) of B.N.S. against the petitioner and other co-accused. Para 3 of his bail petition reveals that petitioner has nine criminal antecedent. It is also evident to mention here that the bail of other similarly placed co-accused have already been rejected by this court vide B.P. No. 2338/2025 & B.P. No. 570/2026.

Considering these facts particularly the nature of offence and stage of the case, I am not inclined to extend the privilege of regular bail to the present petitioner. Accordingly, the present bail petition is rejected.
