|            | <p>Anticipatory bail petition filed on behalf of the petitioner namely 1.) Satyanarayan Prasad@ Satan Bhagat and 2.) Munna Bhagat who are apprehending their arrest in connection with Kuchaikote, P.S. Case No. 147/2019, U/s 341, 323, 324, 307, 379, 504, 506/34 I.P.C.</p> <p>The prosecution story in brief as per the FIR is that on 25.05.2019 around 7:30 am, when the informant was busy in construction of pillar on his plot, at that time, Raja Bhagat, Ramkishun Bhagat, Virendra Bhagat, Lalbabu Bhagat, Madan Bhagat, Ramabhadgat and Munna Bhagat equipped with weapon came at his plot and started verbally abusing him and threatened the informant to leave the plot otherwise they will kill him. When the informant's son along with other persons came to rescue the informant, they started marpit with lathi, farsa and sword. Raja Bhagat attacked Dilip Sharma with farsa on head which caused bleeding and head injury. It is alleged that in this marpit, many persons of the informant side got injured. It is further alleged that Satan Bhagat, Banka Sharma and Rajnarayan Sharma uprooted the pillar made of cement and took away along with iron pipe. Hence, the present FIR.</p> <p>Learned counsel appearing on behalf of the petitioners argued that the petitioner is innocent and has been falsely implicated in this case. Learned counsel further argued that there is land dispute between both the parties. Learned counsel further argued that <b>the petitioners have no criminal antecedent</b>. With these arguments learned counsel for the petitioners prayed for grant of anticipatory bail to the petitioner.</p> <p>Ld. P.P. for the State opposed the bail prayer of the petitioners.</p> <p>Having heard the Id. Counsel for the parties and perused the record. It appears that the original case, now being 7 years old has attained validity, as the investigation is complete and cognizance has been taken. This case pertains to the awaiting appearance of the petitioners. The Lower Court record indicates that a bail petition dated 07.08.2025 filed by these petitioners are still pending. So, the petitioners are directed to surrender to the court below and pray for bail.</p> <p><b>Therefore, at this score it is not a fit case for grant of anticipatory bail to the petitioners.
