This Cr. Misc. Case is put up for hearing.

Heard both the sides.

It is inter alia submitted on behalf of the petitioner that petitioner is the accused in Tr. No. 1476/26 arising out of Gopalganj P.S. Case no. 113/24, which is pending in the court of Id. A.C.J.M.-X, Gopalganj. It is further submitted that petitioner has been granted bail by the Hon'bel High Court, Patna. It is further submitted that the accused was in jail custody in connection of another case hence it was ordered for the production of the petitioner, but the petitioner was not produced before the court, meantime, one petition filed by the prosecution and the D.L.S.A. was directed to appoint an advocate for the petitioner and Vikash Kumar was appointed as defence lawyer, who received police paper. It is further submitted that petitioner filed a petition before the court for production from Buxar jail on 11-07-25 and it was ordered to appear his physically. It is further submitted that the charge was framed on 22-07-2025 through V.C. on 24-07-25 and the next date was fixed for evidence. It is further submitted that the petitioner filed a petition on 18-08-25 but no any order was passed. It is further submitted that the petitioner filed a petition on 23-09-25 but no any order was passed. It is further submitted that the petitioner filed a petition on 17-01-2026 to provide police paper but no order was passed. It is further submitted that the prosecution filed rejoinder of the petition on dated 17-01-26 and the case was fixed for hearing but no any order was passed regarding police paper. It is lastly submitted that from perusal of the entire order-sheet, it appears that no fair trial is conducting by the Id. Court, hence petitioner has filed this transfer petition. Therefore, petitioner has prayed to recall the aforesaid case from the court of Id. A.C.J.M.-10, Gopalganj and transfer it to another competent court for trial and disposal.

Report called for from the court of Id. A.C.J.M.-10, Gopalganj has been received and available on the record. In the report, Id. A.C.J.M.-10, Gopalganj has reported that record of Tr. No. 1476/2026, Reg. No. 2180/2024 is pending in his court, in which next date was fixed on dated 26-02-2026 for appearance and evidence and he has expressed no objection about transfer the said case in another competent court for hearing and disposal.
