This Cr. Misc. Case is put up for hearing.  
Heard both the sides.

It is inter alia submitted on behalf of the petitioner that petitioner is the accused in S. Tr. No. 117/26, which is pending in the court of ld. D.A.S.J.-9, Gopalganj and it is running for prosecution evidence. It is further submitted that record of S. Tr. No. 117/26 is the separate record of S. Tr. No. 769/23, which is pending in the court of ld. D.A.S.J.-10, Gopalganj and it is also running for prosecution evidence. It is further submitted that it is essential to amalgamate both the aforesaid records. Therefore, in the interest of justice, it has been prayed to recall the record of S. Tr. No. 117/23 from the court of ld. D.A.S.J.-9, Gopalganj and transfer it to the court of ld. D.A.S.J.-10, Gopalganj so that both the aforesaid records can be amalgamated.

Reports called for from the Court of ld. D.A.S.J.-9, Gopalganj and ld. D.A.S.J.-10, Gopalganj have been received and available on the record. In their respective reports, ld. D.A.S.J.-9, Gopalganj has reported that record of S. Tr. No. 117/2026 is pending for evidence and the next date is fixed on dated 23-05-2026 and he has expressed no objection about transfer the record of S. Tr. No. 117/2026 and ld. D.A.S.J.-10, Gopalganj has reported that record of S. Tr. No. 769/23 was fixed for framing of charge on dated 04-11-2023 but still prosecution has not produced any witness for evidence and the next next is fixed on 23-05-2026 for prosecution evidence.

Since, both the aforesaid records are connected to each other, which are pending in two different courts.

Considering the aforesaid facts and circumstances of this case and this Cri. Misc. case is partly allowed and the record of S. Tr. No. 769/23 is already pending in the Court of ld. D.A.S.J.-10, Gopalganj. In the interest of justice, the record of S. Tr. No. 117/2026 pending in the court of ld. D.A.S.J.-9, Gopalganj is hereby recalled and transferred to the court of ld. D.A.S.J.-10, Gopalganj for hearing and disposal.
