1. This Regular bail petition filed on behalf of accused petitioner namely **Sajjan @ Md. Ali Raza @ Md. Sajjan @ Sajan Ali Raja**. This bail petition is filed in connection with Jamui P.S case No. 550/2025 lodged U/s-126(2), 115(2), 109, 351 (2&3), 352, 3(5) of B.N.S. Copy of bail petition has been earlier supplied to prosecution.

2. The prosecution case in brief as per written report of informant Sarfuddin S/o Late Md. Nasruddin. On 25-09-2025 at about 5:30 P.M he was going to visit his new house from his old house which is situated in west of Khaira main road. When he reached the house of Kamal Khan then Md. Mahtab, Md. Mustaq, Md. Ekhlak @ Laal Babu, Md. Rajan, Md. Sajan, Md. Sahbaz, Md. Saud along with other five persons all armed with lathi, iron rod and sword surrounded the informant and abused and assaulted him. Md. Mahtab said his associates to kill the informant after this Md. Mahtab with intention to kill the informant assaulted him from sword on his head but during prevention he got hit on his forehead and he got injured. Md. Ekhlak @ Laal Babu armed with lathi assaulted informant on his head when informant tired to save himself he got hit on his right thumb and it got broken. Md. Sahbaaz brought Kabab making stick and stabbed him from it on his forehead and his right cheek due to which he started bleeding. Meanwhile informant's brother tried to save him but Md. Mustaq with intention to kill him also assaulted him from iron rod on his head due to which his brother got covered with blood. Md. Sajjan on the order of Md. Mustaq assaulted Md. Imtiyaz on his right shoulder due to which he got severely injured. Md. Sahbaz armed with iron rod assaulted Md. Imtiyaz on his lips and nose due to which his lips and nose wounded. After hearing hue and cry nearby people came there and saved their life. All the accused/petitioners threatened to kill the informant if he tried to lodge any case against them. The cause of the whole matter is that on 24-09-2025 a fight escalated between informant's son Md. Fiyaz and petitioners Md. Mustaq and Md. Mahtab and informant's brother called police for which the accused petitioners have threatened them that they will have to pay the consequences.

3. It is submitted by the Ld. Counsel for the petitioners that they are quite innocent and have committed no offence. It is also submitted that besides the instant case no criminal proceedings and no other bail applications of instant nature has earlier been filed on behalf of the petitioners mentioned hereinabove either before this court or before the Hon'ble Patna High Court. It is submitted that there is no any criminal antecedent against petitioner. It is further submitted that the petitioner is in custody since 08.05.2026.

4. On the other hand, Learned Add. P.P vehemently opposed the bail and submitted to reject the same.

5. Heard both the Ld. Counsel and peruse the material on record including the F.I.R and Case diary. On perusal of the record it transpires that the F.I.R has been registered against seven known and five unknown persons. The allegation against the petitioner Sajjan @ Md. Ali Raza is that he assaulted informant's brother on his right shoulder due to which he got severely injured. The injury report of informant and his brother as mentioned in case diary shows that Md. Imtiyaz has received following injuries i.e. 1. Lacerated wound size (2'' X ½'' X 1 4'') above the forehead frontal region of skull 2. Lacerated wound size (1'' X 12'' X ¼) on upper lip 3. Lacerated wound of size (1'' X ¼'' X ¼'') on nose 4. diffuse swelling (2X2) on right forearm 5. X-ray of right wrist AP/LAP shows fracture of base of 5th metacarpal bone 6. CT Scan of Brain done at Sadar Hospital Jamui shows fracture of bilateral nasal bones with soft tissue swelling seen injury No. 5 and 6 are grievous in nature while injury report of informant shows 1. Lacerated wound size (¼'' X ¼'' X ¼'') red in color on center of forehead, Diffuse swelling size (1/5'' X 1.5'') on right chest 2. Diffuse swelling of size (1.5'' X 1.5'') right chest and 3. Diffuse swelling on (¼'' X ¼'') on nose 4. CT Scan of brain shows fracture of bilateral nasal bones with soft tissue swelling in nature. Injury No.4 is shown grievous in nature. Independent witnesses mentioned in para-23 and 24 of the case diary have duly supported the prosecution case. The fact that the case is still under investigation. Thus considering the fact and circumstances of the case, the nature of allegation against the petitioners, the role played by the accused petitioners this court is not inclined to grant bail to the petitioner.
