Matter is still pending for the appearance of the O.P. and the petitioner is not taking any steps for the disposal of this case. It appears that the petitioner is not willing to pursue her case.

Accordingly, the this suit bearing Maintenance case number 28/2018 is dismissed for default for non-prosecution.
