ORDER

1. This regular bail petition filed on behalf of above named petitioner, who is in custody since 27.01.2026 in connection with Hulasganj P.S Case No.192/2025 registered under Sections 126 (2), 115(2), 352, 351(3), 74 of BNS is put up and pressed today.
2. Heard learned counsel for the petitioner and learned A.P.P for the State.
3. The prosecution case as stated in the written report of informant, in brief is that on 13.06.2025 at about 04:00 P.M when the informant along with her children was returning home from the house of his brother when on way near Brahmsthan petitioner obstructed them. It is further alleged that petitioner abused and assaulted her by means of lathi. On hearing hue and cry villagers gathered there and then petitioner fled away after leaving his motorcycle and threatened the informant to face dire consequences if the case was not withdrawn.
4. It is submitted on behalf of petitioner that he is innocent and has committed no offence rather he has been falsely implicated in this case at the instance of enemies. Earlier anticipatory bail has been rejected by this court. The petitioner has one criminal antecedent. Furthermore, the petitioner is in custody since 27.01.2026. It is therefore, prayed that the petitioner may be enlarged on bail.
5. The learned A.P.P. strongly opposed the prayer of bail.
6. Heard the argument and perused the record. Perusal of record shows that investigation is complete and charge has also been framed against the petitioner. Besides this accused petitioner is in custody since 27.01.2026. Considering all these aspects particularly the period of detention, I find it proper to grant bail to the present petitioner.

7. Accordingly, the regular bail petition in hand is **allowed** and the petitioner is directed to be released on bail upon furnishing the bail bonds of Rs. 10,000/- (ten thousands) with two sureties of like amount each to the satisfaction of the Ld. court below. **It is further directed that the accused-petitioner namely Amrendra Kumar Singh @ Sadhu Yadav @ Amrendra Kumar @ Amrendra Singh @ Sadhu Ji, shall remain physically present on every date before trial court and if he fails to appear physically for two consecutive dates without proper explanation, the trial court will be at liberty to cancel his bail bond.**
8. A copy of this order be sent to the concerned court.
