ORDER

Both anticipatory bail petitions were filed under section 482 of BNSS on behalf of the three above named accused petitioners who apprehend their arrest in connection with **Kako (Bhelawar) P.S. Case No. 121/26** for the offence **under section 126(2), 115 (2), 118 (2), 109(1), 352, 351(2) and 3(5) of BNS** which is pending in the court of **Ld. S.D.J.M., Jehanabad**.

Anticipatory bail petitions bearing numbers 571/26 & 719/26 are taken up jointly for hearing because both anticipatory bail petitions are related with same **Kako (Bhelawar) P.S. Case No. 121/26**.

The prosecution case as stated in the written report of informant Lalti Devi in brief is that on 22.03.2026 at about 12 o' clock she was harvesting legume when Yogendra Yadav, Naresh Yadav and Kanti Devi came started abusing her. When she protested then Yogendra Yadav assaulted on head with iron rod which caused injury to the head of her husband Suresh Yadav and blood started oozing out. It also caused injury to her nose and shoulder and the shoulder resultantly got fractured. When she fell down then Naresh Yadav and Kanti Devi assaulted her on back and shoulder with iron khanti. Afterwards they fled away and threaten that if she came again in the field then she will be killed.

The Learned counsel for the accused-petitioners submitted that accused-petitioners are innocent and have not committed any offence whatsoever and furthermore there is no criminal

antecedent against them. It is submitted that nothing as alleged ever took place and as a matter of fact there is land dispute among the family members of same family. It is submitted that as a matter of fact informant side has brutally assaulted the petitioner Yogendra yadav and his wife Kanti Devi for which Kako P.S case no 120/2026 was lodged and that is why this false case has been filed. He submits that all the offences are bailable in nature except section 109(1) and 118(2) which are not made out. Accordingly, it is prayed to grant anticipatory bail to the accused petitioners.

Learned A.P.P, opposed the prayer of anticipatory bail.

Heard the argument and perused the record. Perusal of record shows that case diary is available on record. Injury report is also now on record. As per this injury report of Suresh Yadav two injuries are simple in nature while one injury is grievous in nature because fracture was seen in shoulder. Ld counsel has also filed injury reports of petitioner's side which they allegedly sustained in the free fight as submitted and which gave rise to case and counter case. Considering all these facts and circumstances, it is hereby ordered that in the event of surrender or arrest before the Court below/concerned police within fifteen days from the date of receipt of a copy of this order, the petitioners will be released on bail on furnishing bail bond of Rs.10,000/- (Rupees Ten Thousand) with two sureties of the like amount each to the satisfaction of the learned court below/police subject to the condition under the provision of section 482(2) of BNSS. **It is further directed that the accused-petitioner namely 1. Yogendra Yadav shall remain physically present on every date before trial court and if he fails to appear physically on two consecutive dates without proper explanation, the trial court will be at liberty to cancel his bail bond.**
