ORDER

1. Vide instant order, I propose to dispose of aforesaid application for regular bail filed on behalf of the accused Sudhakar Kumar alias Surtam Kumar alias Rustam Kumar, who is stated to be in judicial custody since 27.03.2023 in the aforesaid F.I.R.
2. Briefly stated facts of the case as per FIR registered on 25.07.2021 are that on informant filed a written complaint to SHO P.S. Chautham on 24.07.2021 stating that at about 7:20 p.m. three persons riding on

motorcycle stopped him and looted his mobile and motorcycle bearing Reg. No. BR 10AG 2628.

3. Ld. Counsel for applicant has submitted that applicant is quite innocent and has committed no offence. Applicant has two criminal antecedent and he is in judicial custody since 27.03.2023. F.I.R. is against unknown and name of the applicant has cropped up on the basis of confessional statement of accused before the police. Looted article has been recovered by the police. Charge has been framed in this case non 21.01.2026. Ld. Counsel has also submitted that applicant is ready to abide by all conditions imposed by this court if he is enlarged on bail.
4. Conversely, Ld. P.P. for state has strongly opposed the bail application.
5. Heard. Perused the bail application and L.C.R.
6. F.I.R. is against unknown. Vide B.A. No. 221/2024 while disposing of the same, applicant was granted liberty to renew his prayer for bail after framing of charge. Applicant is in judicial custody since 27.03.2023 and trial is under prosecution evidence. In view of aforesaid facts and circumstances, the applicant is directed to be released on bail on his executing a personal bond of Rs. 10,000/-

(Rupees Ten Thousand Only) with two sureties of like amount each to the satisfaction of the Ld. Court below.

7. B.A. No. 197 of 2026 is hereby allowed.
