ORDER

1. Vide instant order, I propose to dispose of aforesaid application for regular bail filed on behalf of the accused 1. Mirtunjay Kumar and 2. Vishwanath Kumar alias Vishwanath Yadav, who are stated to be in judicial custody since 17.02.2026 in the aforesaid F.I.R.
2. Briefly stated facts of the case as per FIR registered on 24.09.2025 are that on the same very day at 3:00 p.m. three persons including

applicants came riding on a bike where Mritunjay was driving the same and accused Sachin fired bullet upon the informant.

3. Ld. Counsel for applicants has submitted that applicants are quite innocent and have committed no offence. Applicants have no criminal antecedent and they are in judicial custody since 17.02.2026. Alleged sections are not applicable against these applicants. Allegation of firing is against co-accused Sachin Kumar. No weapon was recovered from the possession of applicants. Allegation against the applicants are vague and exaggerated. Ld. Counsel has also submitted that applicants are ready to abide by all conditions imposed by this court if they are enlarged on bail.
4. Conversely, Ld. P.P. for state has strongly opposed the bail application.
5. Heard. Perused the bail application and L.C.R.
6. Charge sheet in this case has already been filed. There is no specific allegation against applicant No. 2 whereas allegation against applicant No. 1 is to drive the motorcycle on which accused were riding. Allegation of firing is on the other accused. Injured has received simple injury caused by hard and blunt substance. Applicants have clean antecedent. In view of aforesaid facts and circumstances, the applicants are directed to be released on bail on their executing a

personal bond of Rs. 10,000/- (Rupees Ten Thousand Only) with two sureties of like amount each to the satisfaction of the Ld. Court below.

7. B.A. No. 255 of 2026 is hereby allowed.
