ORDER

1. Vide instant order, I propose to dispose of aforesaid application for regular bail filed on behalf of the accused Pintu Kumar, who is stated to be in judicial custody since 10.03.2026 in the aforesaid F.I.R.
2. Briefly stated facts of the case as per FIR registered on 20.10.2025 are that informant who is an S.I. of P.S. Beldaur made a written complaint to S.H.O. P.S. Beldaur on 19.10.2025 that he received an information at about 22:12

hours that a fire has broken out in tent and some shops situated in front of Beldaur petrol pump and when the fire tender was sent, local shop keepers and anti social elements attempted to damage vehicle and set them on fire. When informant arrived at the place of incident he saw fire tender burning. About 200 people present there armed with weapon attacked the police force in which seven police personnel were injured. From video footage received from Mahal Chaukidar and local people 50 people were identified. Fire tender worth Rs. 10 lacs was burnt to ashes.

3. Ld. Counsel for applicant has submitted that applicant is quite innocent and has committed no offence. Applicant has no criminal antecedent and he is in judicial custody since 10.03.2026. Other co-accused have been granted bail by this Court. Ld. Counsel has also submitted that applicant is ready to abide by all conditions imposed by this court if he is enlarged on bail.
4. Conversely, Ld. P.P. for state has strongly opposed the bail application.
5. Heard. Perused the bail application and C.D.
6. Applicant is in judicial custody since 10.03.2026. There is no specific allegation against him. Injury of the injured has been opined as simple in nature. No criminal antecedent of the applicant has been pointed out. There is no material on record that he will flee away from the process of law is he is enlarged on bail. Similarly situated, other co-accused have been granted

bail by this Court. In view of aforesaid facts and circumstances, the applicant is directed to be released on bail on his executing a personal bond of Rs. 10,000/- (Rupees Ten Thousand Only) with two sureties of like amount each to the satisfaction of the Ld. Court below.

7. B.A. No. 304 of 2026 is hereby **allowed**.
