ORDER

1. Vide instant order, I propose to dispose of aforesaid application for regular bail filed on behalf of the accused Binodi Paswan, who is stated to be in judicial custody since 24.05.2026 in the aforesaid F.I.R.
2. Briefly stated facts of the case as per FIR registered on 03.05.2026 are that the informant made a written complaint to S.H.O. P.S. Mansi alleging that on 01.05.2026 at about 10:30 P.M. accused persons including applicant came to his door and started abusing him and

when he prevented them from doing so, they assaulted the informant with lathi danda. His nose and head were injured.

3. Ld. Counsel for applicant has submitted that applicant is quite innocent and has committed no offence. Ld. Counsel further stated that applicant has been falsely implicated in this case due to local village politics and family enmity. Ld. Counsel has further submitted that both parties are gotiya and land dispute exists between them. Ld. Counsel further submitted that all alleged sections are bailable except Section-109, 118 of B.N.S. Ld. counsel also submitted that earlier wife of applicant Vimla Devi had lodged complaint case vide Case No. 458C/2025 against the informant of this case. Applicant is in judicial custody since 24.05.2026 and he has six more criminal antecedents. Ld. Counsel has also submitted that applicant is ready to abide by all conditions imposed by this court if he is enlarged on bail.
4. Conversely, Ld. P.P. for state has strongly opposed the bail application.
5. Heard. Perused the bail application and C.D.
6. There is direct allegation against the applicant to hit on the head of the informant with an axe. Doctor has found injury on the left side frontal bone of the informant. Investigation is still pending. In view of

aforesaid facts and circumstances, this court is not inclined to enlarge the applicant on bail.

7. B.A. No. 562 of 2026 is hereby dismissed.
