ORDER

1. Applicant Manoj Kumar @ Deepak Kumar Chourasia has filed aforesaid application u/S. 482 of B.N.S.S. apprehending his arrest.
2. Briefly stated facts of the case as per FIR registered on 03.03.2024 are that in the evening of 02.03.2024 accused persons came to the house of informant carrying country made pistol and hurled abuses upon father of the informant. They also fired gun shots.
3. Ld. Counsel for applicant has submitted that the applicant is quite innocent and has committed no offence. All alleged sections are

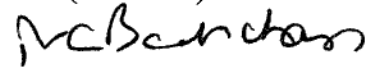
bailable in nature except Section 307 of IPC and Section 27 of Arms Act. Ld. Counsel has further submitted that there is no specific allegation of assault against this applicant and he has been falsely dragged due to suspicion. Ld. Counsel also submitted that co-accused Bipin Singh, Sentu Kumar @ Sintu Yadav have been granted bail by the Hon'ble High Court, Patna vide Cr.Misc. No. 2242/2026 and order dated- 06.04.2026. Ld. Counsel has further submitted that the applicant is ready to abide by all conditions imposed by this court if he is enlarged on anticipatory bail.

4. Conversely, Ld. P.P. for State has strongly opposed the bail application.
5. Heard. Perused the bail application and L.C.R. and Supplementary L.C.R.
6. Applicant was shown as not sent up in the charge sheet. Cognizance has also been taken against him. There is no material on record that the applicant will flee away from the process of law if he is enlarged on bail. There is no complaint of non cooperation by the applicant during investigation. In view of aforesaid facts and circumstances, prayer of applicant for pre-arrest bail is accepted. In the event of arrest or surrender within six weeks from today applicant shall be enlarged on bail on his executing a personal bond of Rs. 10,000/- (Rupees Ten

Thousand) with two sureties of like amount each to the satisfaction of the ld. Court below/Arresting officer.

7. A.B.A No. 618 of 2026 is hereby allowed.
