ORDER

1. Applicants 1. Aditya Kumar @ Mithu and 2. Kajal Kumari have filed aforesaid application u/S. 482 of B.N.S.S. apprehending their arrest in the aforesaid F.I.R.
2. Briefly stated facts of the case as per F.I.R. registered on 25.06.2022 are that on 23.06.2022 at about 4:30 p.m. minor daughter of the informant was kidnapped by the accused persons including applicants.

3. Ld. Counsel for applicants has submitted that the applicants have no criminal antecedent. They have been falsely implicated in this case due to party politics. Ld. counsel has further submitted that no such occurrence as alleged has taken place and Section 366A IPC is not attracted against these applicants. Ld. Counsel has further submitted that applicants are ready to abide by all conditions imposed by this court if they are enlarged on anticipatory bail.
4. Conversely, Ld. P.P. for State has strongly opposed the bail application.
5. Heard. Perused the bail application, C.D. and L.C.R.
6. Applicants are brother and sister. As per statement of the victim recorded u/S. 183 of BNSS, she has married with applicant No. 1. She has not made any allegation against applicants therein. No purpose shall be served by putting applicants behind bar. In view of aforesaid facts and circumstances, prayer of applicants for pre-arrest bail is accepted. In the event of arrest or surrender within six weeks from today applicants shall be enlarged on bail on their executing a personal bond of Rs. 10,000/- (Rupees Ten Thousand) with two sureties of like amount each to the satisfaction of the ld. Court below/ Arresting officer with further conditions that;

- (a) Applicants shall cooperate with the investigation and make themselves available for interrogation whenever required;
 - (b) Applicants shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the fact of the case so as to dissuade him from disclosing such facts to the court or to any police officer;
 - (c) Applicants shall not obstruct or hamper the police investigation and not to play mischief with the evidence collected or yet to be collected by the police;
 - (d) Applicants shall at the time of execution of bond, furnish the address to the investigating officer and the court concerned and shall not change their residence till the final disposal of the case till further orders;
7. A.B.A No. 557 of 2026 is hereby **allowed**.
