ORDER

1. Applicant Mani Kumar has filed aforesaid application u/S. 482 of B.N.S.S. apprehending his arrest in the aforesaid F.I.R.
2. Briefly stated facts of the case as per F.I.R. registered on 26.12.2025 are that on 22.12.2025 at about 4:00 p.m. accused persons including applicant assaulted informant and her family members with *lathi danda*, iron rod and other weapons. As the result husband of the informant received serious injury on his head. Accused persons also demanded extortion of Rs. 50,000/- with threatening that if the same was not paid they would be killed.

3. Ld. Counsel for applicant has submitted that earlier applicant was granted privilege of pre-arrest bail by this Court vide A.B.A. No.- 35/2026 and order dated-27.02.2026 but the applicant could not furnish bail bond within time because he had gone to Andhra Pradesh to earn his livelihood. Ld. Counsel has further submitted that applicant is ready to abide by all conditions imposed by this court if he is enlarged on anticipatory bail.
4. Conversely, Ld. P.P. for State has strongly opposed the bail application.
5. Heard. Perused the bail application and C.D.
6. Applicant was granted privilege of pre-arrest bail on merit vide ABA No. 35/2026 and order dated 27.02.2026. He did not furnish the bail bonds as directed in the aforesaid order. Ground for non submission as per the applicant is that he had gone to earn his livelihood in other state. There is no submission on behalf of prosecution that he did not join the investigation when called by the I.O. In view of aforesaid facts and circumstances, prayer of applicant for pre-arrest bail is accepted. In the event of arrest or surrender within four weeks from today applicant shall be enlarged on bail on his executing a personal bond of Rs. 10,000/- (Rupees Ten Thousand) with two sureties of like amount each to the satisfaction of the ld. Court below/Arresting officer with further conditions that;

- (a) Applicant shall cooperate with the investigation and make themselves available for interrogation whenever required;
 - (b) Applicant shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the fact of the case so as to dissuade him from disclosing such facts to the court or to any police officer;
 - (c) Applicant shall not obstruct or hamper the police investigation and not to play mischief with the evidence collected or yet to be collected by the police;
 - (d) Applicant shall at the time of execution of bond, furnish the address to the investigating officer and the court concerned and shall not change his residence till the final disposal of the case till further orders;
7. A.B.A No. 561 of 2026 is hereby allowed.
