ORDER

1. Vide instant order, I propose to dispose of aforesaid application for regular bail filed on behalf of the accused M.L.A. @ Karelal Kumar, who is stated to be in judicial custody since 08.05.2026 in the aforesaid F.I.R.
2. Briefly stated facts of the case an F.I.R. was registered against accused persons alleging assault by them to the informant. Applicant was granted bail. He absented himself before the Ld. Court below and

NBW was issued against him. He again did not appear and on arrest after proclamation he was remanded on 08.05.2026.

3. Ld. Counsel for applicant has submitted that the applicant was on court bail and did not misuse the privilege of bail intentionally as such pairvikar of the applicant left pairvi as a result his bail bond was cancelled on 10.11.2023. Applicant is in judicial custody since 08.05.2026 and he has no criminal antecedent. Ld. Counsel has also submitted that applicant is ready to abide by all conditions imposed by this court if he is enlarged on bail.
4. Conversely, Ld. P.P. for state has strongly opposed the bail application.
5. Heard. Perused the bail application and L.C.R.
6. Proceeding before Ld. Court below describes a complete saga of accused avoiding the process of law. He was remanded after proclamation on arrest. He is in judicial custody since 08.05.2026 and is sufficiently penalized for his misadventure after jumping bail on 10.11.2023. He is directed to be released on bail on his executing a personal bond of Rs. 10,000/- (Rupees Ten Thousand Only) with two sureties of like amount each to the satisfaction of the Ld. Court below and also subject to his undertaking to the Ld. Court that he will not

absent himself during proceeding and trial of the aforesaid case without sufficient cause.

7. B.A. No. 515 of 2026 is hereby **allowed**.
