ORDER

1. Vide instant order, I propose to dispose of aforesaid application for regular bail filed on behalf of the accused Pankaj Yadav, who is stated to be in judicial custody since 29.04.2026 in the aforesaid F.I.R.
2. Briefly stated facts of the case as per F.I.R. registered on 04.05.2025 are that eight named accused of the F.I.R. and eight other unknown criminals armed with lethal weapon surrounded the informant and his brother namely Sanoj Yadav on 02.05.2025 at about 8:35 p.m. near

Kurmitola Tikarampur village Rahimpur, Distt- Khagaria when they were going on motorcycle driven by Sanoj Yadav. Informant has alleged that Tapsi Yadav ordered to kill Sanoj Yadav and anyhow he ran away from there and arrived his home and informed his family members about the incident. On 03.05.2025 dead body of Sanoj Yadav was found in Ekania Bahiyar. Informant has alleged that his brother was killed with khanti and iron rod and also by putting knot around his neck.

3. Ld. Counsel for applicant has submitted that applicant is quite innocent and has committed no offence. Applicant has one criminal antecedent and he is in judicial custody since 29.04.2026. Other co-accused have already been granted bail by this Court vide B.A. No. 666/2025 and the case of applicant stands on similar footing. Ld. Counsel has also submitted that applicant is ready to abide by all conditions imposed by this court if he is enlarged on bail.
4. Conversely, Ld. P.P.(In-charge) for state has strongly opposed the bail application.
5. Heard. Perused the bail application, L.C.R. and supplementary C.D.
6. Charge sheet against the applicant has already been filed. All witnesses are family members of the deceased and nobody saw the

incident. Applicant is in judicial custody since 29.04.2026. In view of aforesaid facts and circumstances, the applicant is directed to be released on bail on his executing a personal bond of Rs. 10,000/- (Rupees Ten Thousand Only) with two sureties of like amount each to the satisfaction of the Ld. Court below.

7. B.A. No. 541 of 2026 is hereby Allowed.
