ORDER

1. Vide instant order, I propose to dispose of aforesaid application for regular bail filed on behalf of the accused Akhilesh Kumar Yadav, who is stated to be in judicial custody since 03.05.2026 in the aforesaid F.I.R.
2. Briefly stated facts of the case as per FIR registered on 02.05.2026 are that the informant made a written complaint to S.H.O. P.S. Mansi alleging that on 01.05.2026 at 8:30 P.M. applicant along with 4-5 un-

known persons brandished his country made pistol towards the informant and demanded Rs. 50,000/- as extortion and when he protested the accused fired shots. Accused/applicant was neutralized by the informant and his staffs and one country made pistol and three live cartridges were recovered from him.

3. Ld. Counsel for applicant has submitted that applicant is quite innocent and has committed no offence. He has been falsely implicated in this case out of malicious end and at the instance of his enemies. Applicant is in judicial custody since 03.05.2026 and he has one more criminal antecedent. Ld. counsel further submitted that there is case and counter case between the parties. All alleged sections are bailable except section 308(3) of B.N.S. and Section 25(1-B) (a), 26(2), 35 of Arms Act. Ld. Counsel has also submitted that applicant is ready to abide by all conditions imposed by this court if he is enlarged on bail.
4. Conversely, Ld. P.P. for state has strongly opposed the bail application.
5. Heard. Perused the bail application and C.D.
6. Applicant is in judicial custody since 03.05.2026. There is another FIR lodged by wife of the applicant mentioning same date and time. Supervision report mentions the instant case in the category of suspicious one. In view of aforesaid facts and circumstances, the applicant

is directed to be released on bail on his executing a personal bond of Rs. 10,000/- (Rupees Ten Thousand Only) with two sureties of like amount each to the satisfaction of the Ld. Court below.

7. B.A. No. 553 of 2026 is hereby allowed.
