ORDER

1. Applicant Prem Kumar @ Niranjan Kumar has filed aforesaid application u/S. 482 of B.N.S.S. apprehending his arrest in the aforesaid F.I.R.
2. Briefly stated facts of the case as per F.I.R. registered on 03.12.2018 are that on 10.10.2018 accused persons including applicant took KCC loan from the Union Bank of India Jahangira Branch on the basis of forged LPC.
3. Ld. Counsel for applicant has submitted that applicant is quite innocent and has committed no offence. Ld. Counsel has further submitted that there is no criminal antecedent of applicant and there is no specific allegation as alleged against this applicant. There is

general and omnibus allegation against 65 persons. Ld. counsel also submitted that other co-accused namely Sulo Kumar, Sunaina Devi, Sulekha Devi, Dilip Kumar have been granted anticipatory bail vide Cr. Misc. No. 21246/2024, Cr. Misc. No. 17114/2025 and Cr. Misc. No. 62156/2025 respectively. Ld. Counsel has further submitted that applicant is ready to deposit principal amount Rs. 1 lac in the bank and he is also ready to abide by all conditions imposed by this court if he is enlarged on anticipatory bail.

4. Conversely, Ld. P.P. for State has strongly opposed the bail application.
5. Heard. Perused the bail application and LCR.
6. Applicant is ready to deposit Rs. 1 lac which is principal amount according to him, in the Union Bank of India. Ld. Counsel has pointed out orders of Hon'ble High Court passed in Criminal Misc. Case No. 21246/2024 and Criminal Misc. Case No. 62156/2025 whereby co-accused were granted pre-arrest bail on deposit of Rs. 1 lac in the concerned bank. In view of aforesaid facts and circumstances, prayer of applicant for pre-arrest bail is accepted. In the event of arrest or surrender within six weeks from today applicant shall be enlarged on bail on his executing a personal bond of Rs. 10,000/- (Rupees Ten Thousand) with two sureties of like amount each to the satisfaction of the ld. Court below/Arresting officer. This bail is subject to deposit of

Rs. 1 lac in favour of the concerned bank and production of deposit receipt with the bail bonds.

7. A.B.A No. 619 of 2026 is hereby allowed.
