ORDER

1. Applicants 1. Arti Devi, 2. Meera Devi @ Jeera Devi and 3. Suresh Yadav have filed aforesaid application u/S. 482 of B.N.S.S. apprehending their arrest in the aforesaid F.I.R.
2. Briefly stated facts of the case as per FIR registered on 30.03.2026 are that the informant made a written complaint alleging that on 25.03.2026 at about 12:30 P.M. accused persons including the applicant were constructing their house on the disputed land and when her mother in-law Kumiya Devi prevented them from doing so then she was assaulted by them. When the husband of the informant and

devar had gone to rescue Kumiya Devi, they were also assaulted. *Gotini* of the informant Jaimala Devi was also assaulted by them.

3. Ld. Counsel for applicants has submitted that the applicants are quite innocent and have committed no offence. They have been falsely implicated in this case due to grudge and local politics. Ld. counsel further submitted that there is land dispute between the parties. All alleged sections are bailable in nature except Sections 109, 74 of B.N.S. Ld. Counsel has further submitted that applicants are ready to abide by all conditions imposed by this Court if they are enlarged on anticipatory bail.
4. Conversely, Ld. P.P. for State has strongly opposed the bail application.
5. Heard. Perused the bail application and C.D.
6. There is no specific allegation against applicant no. 3 Suresh Yadav. Allegation against applicant no. 1 and 2 is to pull the hairs of *gotini* of the informant and hit her with brick on head. Admittedly there is land dispute between the parties. Injury to the *gotini* of the informant was opined as simple one. Applicants are not at flight risk. No criminal antecedent has been pointed out. In view of aforesaid facts and circumstances, prayer of applicants for pre-arrest bail is accepted. In the event of arrest or surrender in connection with Bahadurpur P.S. Case No.08/2026 within six weeks from today applicants shall be

enlarged on bail on their executing a personal bond of Rs. 10,000/- (Rupees Ten Thousand) with two sureties of like amount each to the satisfaction of the ld. Court below/Arresting officer with further conditions that;

- (a) Applicants shall cooperate with the investigation and make themselves available for interrogation whenever required;
- (b) Applicants shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the fact of the case so as to dissuade him from disclosing such facts to the court or to any police officer;
- (c) Applicants shall not obstruct or hamper the police investigation and not to play mischief with the evidence collected or yet to be collected by the police;
- (d) Applicants shall at the time of execution of bond, furnish the address to the investigating officer and the court concerned and shall not change their residence till the final disposal of the case till further orders;

8. A.B.A No. 621 of 2026 is hereby allowed.
