**JUDGMENT**  
**11.03.2026**

1. The above accused person stands charged under Sections 171(E) and 188 of Indian Penal Code of 1860.

**Story of the Prosecution:**

2. The prosecution story is that the informant's on 06.10.2015 a report has submitted by the Block Development Officer, Beldaur that PCC construction work has been started in Kaijari Panchayat of Beldaur, block by the local

area Engineering Organization, Khagaria under the Planning and Development Department. Abhishek Kumar, Rural Housing Supervisor, Beldaur, submitted a report after on site inspection, stating that the PCC road construction work from the Prime Minister's Village Road to the house of former Chief Siyaram Yadav, with an estimated length of approximately 70 feet and an estimated cost of 7,77,000 was laid on 24.08.2015, but actual field work began only two days ago, a clear violation of the Model Code of Conduct.

**Procedural History:**

3. The Ld. C.J.M took cognizance and transferred this case to this Court for further proceedings. The statements of the accused person has been recorded under Section 313 of the Cr.P.C on dated-06.03.2026, wherein he pleaded innocence.
4. Now, the point of determination is that whether the prosecution has established the case against the accused person under the charged offences.

**DISCUSSION, DECISION AND REASONS THEREOF**

Heard both the Ld. Counsel. Perused the case record.

6. Upon perusal of the case record, the Court finds that no prosecution witness has been produced in this case by the prosecution neither any document has been exhibited against the accused persons. The Ld. APO/ SDPO Jhunnu Kumar Sah has filed an application dated-27.02.2026 for closing of prosecution evidence and, therefore, the prosecution evidence was closed on dated-27.02.2026.

7. This is a case of no evidence. Therefore, the above named accused persons are hereby found not guilty for the want of evidence.

**ORDER**

8. Accordingly, it is, therefore, ordered that the accused person namely  
1. Manoj Kumar, and 2. Vinod Kumar are hereby acquitted of the

charges. The accused persons are already on bail and, therefore, they and their sureties are discharged from liabilities of bail bonds.

9. Office Clerk is directed to deposit the case record in the record room as per law.
