1. Heard learned counsel for the petitioners namely, 1. Md. Azzat @ Ashzad 2. Md. Arbaz @ Arbaz Alam who are in judicial custody since 24-02-2026 in connection with Kishanganj P. S. case No. 168 / 2026 registered u/s 190, 191 (2), 126 (2), 115 (2), 109 (1), 118 (1), of the BNS. Also heard learned P. P. for the state.
 2. Prosecution case in short is that the informant submitted his written report alleging therein that his brothers namely Masud Alam and Mahmood Alam had gone to Marwari college for matriculation examination on 23-02-2026. At about 5.20 p.m. his both brothers came out from the examination center and when reached at road, the petitioners and 3 co- accused persons along with 5 – 6 boys surrounded them. The petitioner no. 2 keep knife at neck of Masud and co- accused Ajmal assaulted him with iron rod upon his head. The co- accused Akmal assaulted his other brother with belt. The other unknown boys started moving bamboo stick and rod and due to that passers- by became injured. The people of locality intervened in the matter and life of his brothers could be saved.

3. Learned counsel appearing for the petitioners submitted that the petitioners have falsely been implicated in this case. The medical reports of the victims are simple in nature. The petitioners are real victims of the incident. The petitioners are in judicial custody since 24-02-2026. The petitioners have clean antecedents.
4. Learned P. P. as well as learned counsel for the informant has opposed the prayer for bail. Learned counsel for the informant submitted that one victim has sustained injury upon his head.
5. Perused the record and case diary. As per allegation, the petitioners and 3 co- accused persons along with some unknown assaulted two brothers of the informant with intention to kill them. The petitioner no. 2 pointed knife at neck of victim Masud and co- accused Ajmal assaulted him with iron rod. The co- accused Akmal assaulted Masud with belt. From injury report of the victims it appears that victim Mahmood Alam sustained abrasion over his right side of back simple in nature and the victim Masud sustained laceration over his skull and palm simple in nature. The petitioners are in judicial custody since 24-02-2025. Statement has been made in para 3 of the bail petition that the petitioners have no criminal antecedent.
