1. Heard learned counsel for the petitioners namely, 1. Tarikul @ Munna 2. Tajuddin @ Taju @ Tajamul Haque 3. Afjal @ Afjal Hussain 4. Anwarul Haque 5. Najmul Haque 6. Inamul Haque who are apprehending their arrest in connection with Kishanganj P. S. case no. 73/ 2026 registered u/s 190, 126 (2), 115 (2), 117 (2), 318 (4), 316 (2), of the BNS. Also heard learned P. P. for the State.

2. Allegation against the petitioners is to assault upon son of the informant with danda for money matters. Due to which son of the informant sustained left eye injury and chest injury.

3. Learned counsel appearing on behalf of the petitioners submitted that the petitioners have falsely been implicated in this case. There is no case made out u/s 318 (4) and 316 (2) against the petitioners. There is no specific allegation against the petitioners. The petitioners have clean antecedents.

4. Learned P. P. has opposed the prayer for anticipatory bail.
5. Perused the record and case diary. There is dispute on the issue of demand for lended money to the petitioner no. 1. Assault with sticks and fists by all the accused persons is alleged. As per injury report, it appears that son of the informant sustained lacerated wound over left hand which is simple in nature caused by hard and blunt object. The petitioners have clean antecedents (from para no. 70 of the case diary).
6. Considering the aforesaid facts and circumstances and nature of allegation against the petitioners, the petitioners namely, 1. Tarikul @ Munna 2. Tajuddin @ Taju @ Tajamul Haque 3. Afjal @ Afjal Hussain 4. Anwarul Haque 5. Najmul Haque 6. Inamul Haque are hereby directed to be released on bail in the event of their arrest or surrender within four weeks from today on furnishing bail bonds of the amount of Rs. 10,000/- with two sureties of the like amount to the satisfaction of the learned court concerned with condition mentioned u/s 482(2) of the BNSS.
