1. Heard learned counsel for the petitioners namely, 1. Pankaj Saha 2. Guddu Mandal who are in judicial custody since 17-01-2026 in connection with Thakurganj P. S. case No. 138 / 2025 registered u/s 319 (2), 318 (4), 323, 3 (5) of the BNS. Also heard learned P. P. for the state.

2. Prosecution case in short is that on 04-07-2025 two Salesmen came and shown the informant powder for cleaning ornaments. They applied red colour powder on her bangle and deceitfully took gold bangle from her. Thereafter they gave her bangle in a powder packet and told to open the same after 10 minutes. They went from there. Thereafter the informant opened the packet but bangle was not found.

3. Learned counsel appearing for the petitioners submitted that the petitioners have falsely been implicated in this case. The petitioners are not named in the FIR. Nothing has been recovered from possession of the petitioners. The petitioners are also accused in four other cases.

4. Learned P. P. has opposed the prayer for bail.

5. Perused the record and LCR. The FIR was registered against unknown as two unknown salesmen deceitfully took gold bangle of the informant. During course of investigation name of the petitioners have come in this case. The petitioner no. 2 and two co- accused persons were identified by the informant and her husband in Whatsapp photo provided by Bhaktinagar P. S. and they stated name of the petitioner no. 1 as their associate in committing the alleged occurrence (vide para 19 and 21 of the case diary). Investigation has been completed and charge sheet has been submitted against the petitioners and two others. Charges have been framed u/s 316 (2), 318 (4), 303 (2), 112(2) of the BNS against the petitioners and others. The petitioners are in judicial custody since 17-01-2026. Statement has been made in para 3 of the bail petition that the petitioners are also accused in four others cases.

6. Considering the aforesaid facts and circumstances and detention period of the the petitioners, the petitioners namely, 1. Pankaj Saha 2. Guddu Mandal are hereby directed to be released on bail on furnishing bail bonds of the amount of Rs. 10,000/- with two sureties of the like amount to the satisfaction of the learned court concerned with condition that the petitioners shall do proper pairvi on each and every date.
