1. Heard learned counsel for the petitioners namely, 1. Mahfooz Alam @ Mahfuz Alam 2. Mariyam @ Mariyam Nisha 3. Farzana Begum 4. Naso @ Naso Begum who are apprehending their arrest in connection with Thakurganj P. S. case no. 172/ 2023 registered u/s 341, 323, 308, 504, 506, 34 of the IPC. Also heard learned P. P. for the State.

2. Prosecution case in short is that on 19-07-2023 the petitioners and six co- accused persons assaulted the informant and his family members. The petitioner no. 1 and FIR named accused Kamisnar assaulted the informant with dabia and hasua with intention to kill him . Due to intervention of labourers his life could be saved.

3. Learned counsel appearing on behalf of the petitioners submitted that the petitioners have falsely been implicated in this case. The alleged date of occurrence is of 19-07-2023 whereas the FIR was lodged on 01-08-2023 after a delay of 13 days. Notice u/s 41 (1) of the Cr. P. C. has been issued to the accused persons and they have been benefited u/s 41 (1) Cr. P. C.
4. Learned P. P. has opposed the prayer for anticipatory bail.
5. Perused the record and LCR. As per allegation, the petitioners and co-accused persons assaulted the informant and his family members with intention to kill them. The petitioner no. 1 assaulted him with dabia upon his head. In this case charge sheet was submitted against the petitioners u/s 341, 323, 308, 504, 506/34 of the IPC exonerating six co-accused persons and accordingly cognizance has been taken. The petitioners were granted benefit u/s 41 (1) of the Cr. P. C. From injury report of the informant it appears that he sustained injuries simple in nature caused by hard and blunt substance.
6. Considering the aforesaid facts and circumstances and submission on behalf of the parties, the petitioners namely, 1. Mahfooz Alam @ Mahfuz Alam 2. Mariyam @ Mariyam Nisha 3. Farzana Begum 4. Naso @ Naso Begum are hereby directed to be released on bail in the event of their arrest or surrender
