1. Heard learned counsel for the petitioners namely, 1. Zaber Alam 2. Abdul Rahim who are in judicial custody since 31-01-2026 in connection with Pothia P. S. case No. 330 / 2025 registered u/s 136 Bihar Electricity Act. Also heard learned P. P. for the state.

2. Prosecution case in short is that on 26-12-2025 it was informed that 1.8 CKM HT wire of 11 KV was stolen away by some unknown thieves.

3. Learned counsel appearing for the petitioners submitted that the petitioners have falsely been implicated in this case. F.I.R. has been lodged against unknown persons. Nothing has been recovered from possession of the petitioner. Investigation has been completed and charge sheet has been submitted , so no further custodial interrogation is required. The petitioners are in judicial custody since 31-01-2026. The petitioners are also accused in four other cases.

4. Learned P. P. has opposed the prayer for bail.

5. Perused the record and LCR. The case was registered against unknown for committing theft of 1.8 CKM HT wire of electric department. Name of petitioners have come in this case during course of investigation. The petitioners in their confessional statement recorded in connection with Paharkatta P. S. case no. 142/ 2025 have confessed their involvement in the present occurrence. Investigation has been completed and charge sheet has been submitted against the petitioners and others u/s 136 of the Electricity Act. Charge has been framed u/s 136 of the Electricity Act and the case is at the stage of prosecution evidence. The petitioners have been remanded in this case on 31-01-2026 and since then they are in judicial custody. Statement has been made in the bail petition that the petitioners are also accused in three others cases.
6. Considering the aforesaid facts and circumstances and detention period of the the petitioners, the petitioners namely, 1. Zaber Alam 2. Abdul Rahim are hereby directed to be released on bail on furnishing bail bonds of the amount of Rs. 10,000/- with two sureties of the like amount to the satisfaction of the learned court concerned.
