1. Heard learned counsel for the petitioner Somen Saha @ Bangali who is in judicial custody since 19-01-2026 in connection with Kishanganj P. S. case No. 485 / 2025 registered u/s 305 (a) of the BNS. Also heard learned P. P. for the state.
2. Prosecution case in short is that on 25-08-2025 sister of the informant had come to his house. She had a purse containing Rs. 60,000/- and ornaments of worth Rs. 15 lakh. She kept the purse in a room and went for refreshment. When she returned her purse was missing. The informant claimed that some unknown person had committed theft of his sister's purse. In the purse there was a mobile phone also.
3. Learned counsel appearing for the petitioner submitted that the petitioner has falsely been implicated in this case. Nothing has been recovered from possession of the petitioner. The co-accused Damru @ Munajir Alam has been granted bail by this court earlier. The petitioner is in judicial custody since 19-01-2026. The petitioner is also accused in one other case.
4. Learned P. P. has opposed the prayer for bail.

5. Perused the record and LCR. The case was registered against unknown for committing theft of purse of sister of the informant containing Rs. 60,000/- cash and ornament of worth Rs. 15 lakh and it was identified by the neighbourers in video camera. During course of investigation name of the petitioner has come in this case only in confessional statement of co- accused Damru @ Munazir. The petitioner is judicial custody since 19-01-2026. Statement has been made in para 3 of the bail petition that the petitioner is also accused in one other case of similar nature.

6. Considering the aforesaid facts and circumstances, the petitioner Somen Saha @ Bangali is hereby directed to be released on bail on furnishing bail bond of the amount of Rs. 10,000/- with two sureties of the like amount to the satisfaction of the learned court concerned with condition that the petitioner shall file an undertaking to the effect that after release on bail if the petitioner is remanded in any other case of similar nature, his bail bond shall stand cancelled.
