18-06-2026 1. Heard learned counsel for the petitioner namely, Narayan, who is apprehending his arrest in connection with Bahadurganj P.S. case no.-24/2025, u/s 137(2), 140(3), 96, 3(5) of BNS. Also heard learned P. P. for the State.

2. Prosecution story as per written report of informant is that on 11.01.2026 his minor daughter gone for school but she did not return till long then he and his family members started searching her. During search they got information that petitioner Pintu along with other Co-accused persons kidnapped his daughter with wrong intention. He is further stated that when he went to the accused house where Ajay Kumar abused and assaulted and threatened him. Her daughter bearing the gold and silver ornaments. He believed that the petitioner along with other co-accused persons kidnapped her daughter. On the basis of written report of the informant Bahadurganj P.S. Case NO. 24/2025 was registered.

3. Learned counsel appearing on behalf of the petitioner submitted that the petitioner is innocent and he has not committed any offence. All the allegations made in the FIR is totally false, fabricated, fictitious and concocted. He is further stated that the Pintu with the other co-accused persons not kidnapped the informant's daughter. But when the informant forcibly want to marry his daughter with another persons, she ran away with his love Pintu. The police recover the victim and produced the victim before the C.J.M., kishanganj and recorded her statement U/s 183 BNSS. She stated in her statement that she do not want to go with her parent but she want to go with Pintu and she gave birth to a child. The victim do not support the informant case. NO case made out against the petitioner. The petitioner is a young boy and his is living outside for earning his livelihood. The petitioner is the brother of Pintu. The petitioner is ready to abide all the conditions as laid down U/s 482 BNSS. Statement has been made in para 3 of the bail petition that the petitioner has clean antecedent.

4. Learned P. P. has opposed the prayer for bail.
5. From perusal of record it transpires that there is allegation against this petitioner that he was involved in kidnapping of daughter of the informant along with other co-accused persons. During investigation statement of victim was recorded U/s 183 BNSS in which she has stated that she had married with Pintu 13 months ago on her sweet will. None has kidnapped her. She gone with Pintu on her sweet will. She has a son aged about 21 days with wedlock with Pintu. The victim has not made any allegation against this petitioner. From perusal of medical report attached with the case diary it transpires that age of victim has been determined 19 years. It shows that the victim is major. There is no specific allegation of kidnapping against this petitioner. Considering the facts stated above, I am inclined to enlarge the petitioner of bail.
6. Considering the aforesaid facts and circumstances, the petitioner namely, Narayan is hereby directed to be released on bail in the event of his arrest or surrender within four weeks from of receipt of the copy of this order in learned Trial Court, on furnishing bail bond of the amount of Rs. 10,000/- with two sureties of the like amount to the satisfaction of the learned court concerned subject to the conditions laid down under Section 482 of the BNSS.
