1. Heard learned counsel for the petitioners namely, 1. Md. Akhtar 2. Manzar Alam 3. Md. Alauddin 4. Md Iftekhar 5. Mahboob Alam @ Khus Mohammad @ Gajwa 6. Majid Alam 7. Rafique Alam who are apprehending their arrest in connection with Thakurganj P. S. case no. 141/ 2026 registered u/s 329 (4), 308 (3), 308 (2), 352, 351 (2), 3 (5) of the BNS. Also heard learned P. P. for the State.
 2. As per prosecution case on 07-04-2026 the accused persons forcefully entered the tea garden plot and attempted to build house on the said plot and demanded ransom of Rs. 5 lac.
 3. Learned counsel appearing on behalf of the petitioners submitted that the petitioners have falsely been implicated in this case. There is a land dispute between the parties. Offence u/s 308 (3), 308 (2), of the BNS does not attract against the petitioners. The petitioners have clean antecedents.
 4. Learned P. P. has opposed the prayer for anticipatory bail.

5. Perused the record and case diary. There is land dispute between the parties and there is no particular civil case. As per averment made in the case diary, learned P. P. stated that possibility of compromise is being done between the parties. Statement has been in para 3 of the bail petition that the petitioners have clean antecedents.

6. Considering the aforesaid facts and circumstances and harmony between the parties, the petitioners namely, 1. Md. Akhtar 2. Manzar Alam 3. Md. Alauddin 4. Md Iftekhar 5. Mahboob Alam @ Khus Mohammad @ Gajwa 6. Majid Alam 7. Rafique Alam are hereby directed to be released on bail in the event of their arrest or surrender within four weeks from today on furnishing bail bonds of the amount of Rs. 10,000/- with two sureties of the like amount to the satisfaction of the learned court concerned .
