1. Heard learned counsel for the petitioners namely, 1. Sarwar Alam 2. Sabir Alam @ Md. Sabir Alam 3. Jabir Alam 4. Khatib Alam @ Mohammad Khatib who are apprehending their arrest in connection with Kochadhaman P. S. case no. 37/ 2026 registered u/s 126 (2), 115 (2), 118 (1), 109 (1), 351 (2), 352, 3 (5) of the BNS. Also heard learned P. P. for the State.

2. Prosecution case in short is that on 21-01-2026 at 1.00 p.m. when the informant along with his grandson was going to a wedding occasion on his motorcycle, his motorcycle slipped because laborers working on the road sprinkled water over there. Due to which the informant and his grandson got injured. The petitioners along with co-accused Abdul Kuddus assaulted the informant with lathi danda for little dispute and his nephew were threatened for killing.

3. Learned counsel appearing on behalf of the petitioners submitted that the petitioners have falsely been implicated in this case. There is no specific allegation against the petitioners rather it is omnibus in nature. The alleged medical report is found simple in nature. The petitioners have clean antecedents.

4. Learned P. P. has opposed the prayer for anticipatory bail.

5. Perused the record and case diary. As per allegation the petitioners along with co-accused Abdul Kuddus assaulted the informant with lathi danda for little dispute. There is general and omnibus allegation against the petitioners for altercation on the issue of water flowing from brick kiln. As per injury report, it appears that the informant sustained lacerated wound over left eyebrow which is simple in nature caused by hard and blunt object.

6. Considering the aforesaid facts and circumstances and nature of allegation against the petitioners, the petitioners namely, 1. Sarwar Alam 2. Sabir Alam @ Md. Sabir Alam 3. Jabir Alam 4. Khatib Alam @ Mohammad Khatib are hereby directed to be released on bail in the event of their arrest or surrender within four weeks from today on furnishing bail bond of the amount of Rs. 10,000/- with two sureties of the like amount to the satisfaction of the learned court concerned.
