16-06-2026 1. Heard learned counsel for the petitioner namely, Zeeshan, who is in custody since 03.05.2026 in connection with Kishanganj P.S. Case No. 470/2026, registered u/s 182(2), 115(2), 126(2), 191(2), 191(3), 74, 76, 351(3) of BNS. Also heard learned P. P. for the State.

2. Prosecution story as per typed report of informant is that On 02.05.2026 at about 09:30 PM, all of the accused person including this petitioner armed with deadly weapons entered the informant's house and started abusing, assaulting and misbehave with the informant. When the husband of the informant tried to save her accused Dilwar assaulted on the head of the informant with sword due to which he sustained injury. Accused Rafik Alam assaulted on the ear of the informant's husband with pistol's wat due to which he sustained injury. On halla villagers came there and save them. Informant further stated that the accused persons followed the informant and her husband to Sadar Hospital, Kishanganj, where they again attempted to attack but fled on arrival of officials. On the basis of written report of informant Kishanganj P.S. Case No. 470/2026 was registered.

3. Learned counsel appearing on behalf of the petitioner submitted that the petitioner is innocent and he has not committed any offence. The dispute arises out of an air conditioner external unit's water overflow. Injuries are exaggerated and subject medical verification; custodial interrogation of the applicant is not necessary for the purpose of investigation. This is a counter to the case vide Kishanganj P.S. case No. 471/2026 which is against the informant and his family members. The petitioner's brother Ehsan was himself subject of physical assault with a head injury and the other accused persons took him for treatment to Sadar Hospital. There has been animosity between both the parties. There was another case lodged by accused_1 in the year 2018 vide Kishanganj P.S. Case NO. 353/2018. The petitioner is in custody since 03-05-2026. As per para 03 of bail petition, petitioner has clean antecedent.

4. Learned P. P. has opposed the prayer for bail.
5. From perusal of record it transpires that there is allegation against this petitioner that he along with other co-accused persons came to the house of the informant armed with lathi, danda and sword and started abusing the informant and when the informant prohibited them, they misbehaved her and when her husband came to save her then co-accused Dilwar assaulted with sword on the head of the informant and Rafik assaulted with wat of the pistol on the head of the husband of the informant due to which he sustained injuries and fell on the ground. There is no specific allegation against this petitioner. Specific allegation of assault is against co-accused persons Dilwar and Rafik. Injuries of injured has been found grievous in nature by the doctor but the allegation of assault is on other accused persons and there is no specific allegation of assault against this petitioner. The petitioner is in custody since 03.05-2026. Considering the facts and period of custody already undergone by the petitioner, I am inclined to enlarge the petitioner on bail.
6. Accordingly the petitioner namely, Zeeshan is hereby directed to be released on bail on furnishing bail bond of the amount of Rs. 10,000/- with two sureties of the like amount to the satisfaction of the Learned Court Concerned.
