1. Heard learned counsel for the petitioners namely 1. Mushrraf Ansari 2. Md. Shahjada @ Sakil who are in judicial custody since 08-05-2026 in connection with Kishanganj P. S. case No. 502 / 2025 registered u/s 190, 191 (3), 126 (2), 115 (2), 117 (2), 118 (2), 109 (1), 132, 74, 262, 263 (a), 265 of the BNS. Also heard learned P. P. for the state.

2. Prosecution case in short is that the informant Police Officer submitted her written report alleging therein that arrested accused of another case disclosed that the stolen articles were in possession of co- accused persons. The police team reached at the house of co- accused Kudrat for recovery of stolen articles. He was taken into custody for enquiry. But in the meantime, co- accused Kurdrat, his family members and 20 – 25 associates armed with weapons attacked on police team. The members of team sustained serious injuries. Co-accused Sahnaz Khatoon was identified as leader of the miscreants and she was apprehended. The apprehended co- accused Kudrat and others fled away. Thirteen FIR named accused persons including the petitioners were identified with the help of local people.

3. Learned counsel appearing for the petitioners submitted that the petitioners have falsely been implicated in this case. The petitioners are no where involved in the alleged case and the accusations levelled against them are general in nature. Co-accused persons have been granted regular bail by this court earlier. The petitioners are in judicial custody since 08-05-2026.

4. Learned P. P. has opposed the prayer for bail.
5. Perused the record and case diary. As per allegation, when the police team apprehended co- accused Kudrat in connection with other case the petitioners and others attacked on police team. The petitioners and others were identified with the help of local persons. There is no specific allegation of assault against the petitioners. From injury report of the four victims, it appears that they sustained injuries simple in nature. Similarly situated co- accused persons have been granted regular bail by the predecessor of this court. The petitioners are in judicial custody since 08-05-2026.
6. Considering the aforesaid facts and circumstances, the petitioners namely, 1. Mushrraf Ansari 2. Md. Shahjada @ Sakil are hereby directed to be released on bail on furnishing bail bonds of the amount of Rs. 10,000/- with two sureties of the like amount to the satisfaction of the learned court concerned.
