10.06.2026 Heard both sides on the petition dated 09.06.2026 filed on behalf of petitioners namely, 1) Harihar Sahu Keshari alias Harihar Prasad Keshri, 2) Madhuri Devi, 3) Alok Keshari alias Alok Kumar, 4) Aman Keshari.

2. It is submitted on behalf of the petitioners that vide order dated 02.04.2026 passed in connection with Complaint Case No. 265 of 2024 the petitioners have been granted anticipatory bail but due to typographical mistake the address of the petitioners and father name of Petitioner No. 04 have wrongly been typed in the bail petition and consequently the same mistake has been occurred in the order dated 02.04.2026 due to which the petitioners could not surrender within the time stipulated for and, therefore, it is prayed that permission to correct the address of the petitioner as “Ward No. 23 PS Bhabua, Distt. Kaimur and Father’s name of Petitioner No. 04 as Late Ravi Keshari @ Ravi Shankar Prasad” in the bail petition may granted and thereafter the same may be corrected in the order dated 02.04.2026. It is further prayed that the period stipulating the surrender of the petitioner may also be extended for a further time

3. Considering the submissions made above the permission as sought for to correct address of the petitioners and father’s name of Petitioner No. 04, is accorded and consequently the address of the petitioners and father’s name of Petitioner No. 04 in the order dated 02.04.2026 be read as “Ward No. 23 PS Bhabua, Distt. Kaimur and Father’s name of Petitioner No. 04 as Late Ravi Keshari @ Ravi Shankar Prasad” and a further period of one week from the date of receipt of a copy of this order, stipulating the surrender of the petitioners, is extended. The petitioners are directed to make correction as aforesaid in the bail petition.

Accordingly, this interlocutory application is **disposed of.** (Dictated)
