SESSIONS JUDGE-II, KAIMUR AT BHABUA</b><br/> <b><u>Anticipatory Bail Petition No. 985 of 2026</u></b><br/> Majhil @ Sahzad Ansari &amp; Ors V/s State</p> <p>An anticipatory bail petition filed on behalf of the accused-petitioners namely <b>Majhil @ Sahzad Ansari, Tetari Bibi @ Tahera Khatoon, Shabanam @ Shabanam Khatoon, Shama Parveen, Imamuddin Ansari @ Amamuddin Ansari, Sartaz Alam, Mehtab Alam and Samsun Bibi @ Samsun Nesha</b> who are apprehending their arrest in connection with Bhagwanpur P.S Case No. 127 of 2026 registered for the offence U/s 126(2), 115(2), 118(1), 109(1), 303(2), 352, 3(5) of BNS. Copy of bail petition has duly been served to Id. A.P.P. Heard learned counsel Sri Vijay Kumar on behalf of the petitioners and learned APP for the State as well as learned counsel Sri Ghanshyam Kumar for the informant.</p> <p>Prosecution story in short is that, on 19.05.2026 in the morning Immamuddin Ansari who is residing beside the house of the informant generally thrown garbage on the roof of informant. On protest the accused petitioner started abuses to the informant and son of the Immamuddin namely Mehtab Alam came there and started assaulting. They got alone brutally assaulted the informant, Sartaz gave knife blow and Mehtab assaulted the informant with iron rod, in result the informant sustained injuries in his hand and head. Further alleged that they snatched gold chain and Rs.15000/- of the informant. When informant's daughter came there the accused persons also assaulted her. Hence, this case.</p> <p>Learned counsel for the accused petitioners submit that they are quite innocent and have committed no offence whatsoever. Earlier petitioners have not filed any bail application either in this court or any superior court. Petitioners have no criminal antecedent. All the alleged sections are bailable except 118(1), 109(1) &amp; 303(2) of BNS and are super added only with a view to make this case non-bailable. There is case and counter case between the parties. On the basis of above facts Id. counsel for the accused petitioners submit that they are entitled for anticipatory bail.</p> <p>On the contrary Id. counsel for the prosecution has vehemently opposed the prayer for anticipatory bail.</p> <p>Heard both the sides. Perused the case record as well as case-diary. On perusal it transpires that petitioners are carrying an allegation of assault to the informant and his daughter. The informant received injuries on his person at left parietal region of head and fracture on the ribs bone, which is grievous in nature. There is repeated blow on the ribs of informant. In these circumstances I do not find it proper to grant anticipatory bail to the petitioners.
