SESSIONS JUDGE-II, KAIMUR AT BHABUA <u>Bail Petition No. 297 of 2026</u> Danish Alam @ Sheru V/s State The instant bail petition filed on behalf of the accused-petitioner namely Danish Alam @ Sheru who is in custody since 17.10.2025 in connection with Bhabhua P.S Case No. 862 of 2025 registered for the offence U/s 25(1-b)a, 26 of Arms Act. Copy of bail petition has duly been served to ld. A.P.P. Heard learned counsel Sri Vikash Kumar on behalf of the petitioner and learned APP for the State. Case of prosecution in short, is that, on 18.10.2025 at about 08:50hrs police got secret information that accused of Bhabhua P.S Case No. 861/2025 registered for the offence U/s 103(1),3(5) BNS is tried to fled away. On verification of such information police proceeded there and apprehend the accused person with one country made pistol with two live cartridges. On query he neither produced document nor replied satisfactorily. Further he disclosed his name. Thereafter, stated that he murdered yesterday by this pistol. Accordingly seizure list prepared. Hence, this case. Learned counsel for the accused petitioner submit that he is quite innocent and has committed no offence whatsoever. Earlier petitioner has not preferred any bail either in this court or any superior court. Petitioner has similar criminal antecedents. There is nothing specific against the petitioner. No overt act was done by the petitioner. Accused petitioner is in custody since 17.10.2025. On the basis of above facts ld. counsel for the accused petitioner submits that he may be granted bail. On contrary ld. APP has vehemently opposed the prayer for bail. Heard both the sides. Perused the lower case record. On bare perusal of record it transpires that one Bhabhua P.S Case No. 861/2025, U/s 103(1),3(5) BNS was registered against the accused petitioner on 15.10.2025 and on the next day on 16.10.2025 in the event of arrest of petitioner instant case has been registered vide Bhabhua P.S Case No. 862/2025, U/s 25(1-b)a, 26 of Arms Act, in course of same transaction. The petitioners bears criminal antecedents of offence of heinous nature and the arms and ammunition which are seized in this case being used in murder of Ramlal Mallah i.e Bhabhua P.S Case No. 861/2025. Considering the aforesaid facts and gravity of offence, I am not inclined to enlarge the petitioner on bail. Accordingly, prayer for bail of the petitioner above named is hereby rejected.
