SESSIONS JUDGE-II, KAIMUR AT BHABUA <u>Bail Petition No. 378 of 2026</u> Nawal kishore Prasad & Ors V/s State The instant bail petition filed on behalf of the accused-petitioners namely SAP No. 6929 Nawal Kishore Prasad, SAP No.1139 Chandrabhusan Singh, SAP No.9054 Anil Kumar Singh and SAP No.5518 Manoj Kumar who are in custody since 07.07.2026 in connection with Mohania P.S Case No. 505 of 2026 registered for the offence U/s 308(3), 308(5) of B.N.S. Copy of bail petition has duly been served to Id. A.P.P. Heard learned counsel Sri Ashok Kumar Singh on behalf of the petitioners and learned APP for the State. The case in short is that on 07.07.2026 at about 03:30 o' clock an information was received that SAP deployed at Check Post situated at northern and southern side of G.T.Road about 300 meter east of Durgawati Toll Plaza were illegally extorting money from passing heavy vehicles with the assistance of locals. Accordingly raid was conducted led by Inspector-cum-SHO Alok Kumar. On arrival of raiding team several deployed SAP Jawans and private associates tried to flee away, on chase they were apprehended. Thereafter statement of trucks drivers were taken they confirmed that the accused petitioners were extorting money through intimidation, threatening of heavy fines etc. Lastly search of apprehended persons were made and mobiles as well as cash of Rs.56,160/- were recovered thereon. Accordingly seizure list was prepared. Hence, this case. Learned counsel for the accused petitioners submit that they are quite innocent and have committed no offence whatsoever. Earlier petitioners have not filed any bail application either in this court or any superior court. Petitioners have no criminal antecedent. There is nothing specific against these petitioners. All petitioners are SAP Jawans. Accused petitioners are in custody since 07.07.2026. On the basis of above facts Id. counsel for the accused petitioners submits that they may be granted bail. On contrary Id. APP has vehemently opposed the prayer for bail. Heard both the sides. Perused the case record. On perusal it transpires that on query of truck drivers it has been disclosed that an extortion was committed by means of passing through check post of heavy vehicles trucks by intimidation and threatening of heavy fines etc. Allegations are omnibus in nature. Moreover, petitioners are in custody since 07.07.2026. Considering the period of custody, facts and circumstances of the case, the accused / petitioners are directed to be released on bail on furnishing bail-bond of Rs.10,000/- with two sureties of the like amount each to the satisfaction of the court below.
