ORDER

24.04.2026- This anticipatory bail petition has been filed on behalf of accused-petitioner namely Md Firoz Ansari who is apprehending his arrest in connection with aforesaid case.

Heard the Ld. counsel Shri Sanjay Kumar Singh appearing on behalf of the petitioner and Ld. A.P.P. Shri Md. Azaj Alam on behalf of the state.

According to F.I.R., prosecution case in nutshell is that, informant to this case namely Abdul Rahim lodged a written report before S.H.O., Town Katihar alleging therein that his marriage was solemnised on 05.11.2012 with Rukshar Khatoon. On wedlock with her he has three children. Informant has further alleged that accused-petitioner namely Md Firoz Ansari used to talk with her wife through mobile and WhatsApp and on that very point panchayati was also convened but matter could not be resolved. Informant has further alleged that from dated 05.02.2026 at about 10:00 o' clock, his wife and three children are not at home. When he took information from her maika then he came to know that she is not there. Informant has further alleged that he had gone to his sasural and at the house of Firoj Ansari but nothing could come into knowledge and mobile phone of both persons are switched off. Accordingly, informant has expressed his suspicion that Firoz Ansari has abducted and kidnapped his wife and three children. He may commit any mis-happening with his wife and children. Informant has further alleged that on search, he came to know that his wife has taken away Rs. 80,000/- in cash, 15 gram gold ornaments and other papers along with her.

On the other side learned counsel for the petitioner has reiterated all the grounds taken in the bail petition and has submitted that the accused-petitioner is innocent and allegation as levelled against him is totally false, fabricated and concocted. Only on the basis of suspicion, petitioner has named in the F.I.R. Real fact is that Rukshar Khatoon who is the wife of the informant is a victim of domestic violence and due to that very reason, petitioners and informant's wife developed mutual love. It is further submitted that due to consistent domestic violence, informant's wife left her house and went with the petitioner and petitioner is ready to

marry with her. Accordingly, it has been submitted to allow the instant anticipatory bail petition.

Per contra, Learned A.P.P. has vehemently opposed the prayer for anticipatory bail.

Heard both parties and perused the case record. From perusal of the case record it is evident that, informant's wife namely Rukshar Khatoon is major and aged person, her age is 35 years and in her statement recorded U/s 183 of B.N.S.S., she has clearly stated that as per her own free will she went Bhagalpur with accused-petitioner namely Firoz Ansari and there is no allegation against the petitioner that he played an active role in taking away the alleged cash and valuable articles.

So having considered the above facts and submissions made by the Ld. Counsel for the petitioner, the instant anticipatory bail petition is hereby allowed and accordingly it is ordered to release the petitioner namely **Md Firoz Ansari** on bail in the case of surrender/arrest within three weeks of this order on furnishing of bail bond of Rs. 10,000/- with two sureties of the like amount each to the satisfaction of the learned court concerned subject to the condition as mentioned in the section 482 (2) of the B.N.S.S.
