Noushid Alam alias Naushad Alam with the prayer to extend the time of surrender by two weeks in connection with A.B.P. No.1359 of 2025 arising out of Azamnagar P.S. No.70 of 2025. 2. This Criminal Miscellaneous application has been pressed by the learned counsel for the petitioner who submitted that the petitioner was allowed anticipatory bail in connection with Azamnagar PS case no. 70 of 2025 in ABP no. 1369 of 2025 by the order dated 20.01.2026. Two weeks time was granted to the petitioner for surrendering before the learned court concerned. However, the petitioner had gone outside so he could not appear before the learned court concerned. Therefore, prayer has been made to extend the time of surrender by two weeks. 3. Also heard the Learned APP. Perused the record. From the perusal of the record, it transpires that the accused petitioner namely Md. Noushid Alam alias Naushad Alam was granted anticipatory bail by this court in ABP no. 1369 of 2025 arising out of Azamnagar PS case no. 70 of 2025 by the order dated 20.01.2026. The said case is under sections 115(2), 126(2), 85, 351(2), 3(5) of Bhartiya Nyaya Sanhita and under sections 3 and 4 of Dowry Prohibition Act. Two weeks time was granted to the petitioner for surrendering before the Learned Court concerned. However, according to the petitioner, as he was outside, he could not surrender within time. In the
