ORDER

10-04-2026 Aforesaid both bail petitions have been filed on the behalf of accused-petitioners namely **Ansari Khatoon & Md. Zabbar@Zafar** who are in custody since 06.03.2026 and 09.02.2026 in connection with aforesaid case. Since aforesaid both bail petitions arise from same and one case, so both bail petitions are hereby disposed of by this common order.

Heard the learned counsel Shri Md. Sahin Akhtar appearing on the behalf of the petitioner and learned A.P.P. Sri Md. Ajaz Alam appearing on the behalf of the State and perused the lower court record along with case diary.

According to F.I.R. prosecution case in nutshell is that informant to this case namely Sahela Khatoon lodged a written report before SHO Balia Belon stating there in that marriage of her daughter namely Nujhat Bano was solemnized as per Muslim customs six months ago. Informant has further alleged that her daughter always used to say through telephone that Md. Zabbar @ Zafar and other co-accused named in FIR used to comment physical and mental torture due to dowry demand and her sautan(second

wife of husband) is giving threatening to kill her. Informant has further alleged that on dated 20.01.2026 at about 7:30 AM, she received information that Nujhat Bano has been shot then she went at the matrimonial house of her daughter and saw that her daughter has died due to bullet injury. Informant has further alleged that after hatching of conspiracy with each other, aforesaid all accused persons have got murdered to her daughter by shooting her.

On the other side learned counsel for the petitioners have submitted that petitioners are innocent and have committed no offence and all the allegation levelled against the petitioners are totally false and concocted and they have falsely been implicated in this case by the informant. Ld. Counsel further submitted that Ansari Khatoon has not named accused in FIR but some other co-accused has taken the name of the Ansari Khatoon in their confessional statement and Ansari Khatoon is housewife. It has been further submitted that both petitioners have no criminal antecedents and they have no any type of involvement in this alleged occurrence. Ansari Khatoon is in custody since 06.03.2026 while Md. Zabar @ Zafar is in custody since 09.02.2026. Accordingly, it has been submitted to enlarge the petitioners on bail.

Per contra, learned A.P.P. appearing for the state has opposed the prayer for bail and has submitted that Md. Zabar @ Zafar is FIR named accused and Ansari Khatoon is not named accused of FIR but her name has been surfaced on the basis of confessional statement of Md. Zabar @ Zafar and there is allegation against accused petitioners that they and their family members committed murder of the informant's daughter namely Nujhat Bano due to non fulfillment of dowry demand and case is under investigation. Accordingly, prayer has been made to reject the said both bail petitions.

Heard the both parties and perused the record. From perusal of the record it is evident that Md. Zabar @ Zafar is the named accused of F.I.R. and there is allegation against him that he and other co-accused persons committed murder to the Nujhat Bano due to non fulfillment of dowry demand. Further accused petitioner namely Ansari Khatoon is not named accused in F.I.R. but co-accused Md. Zabar @ Zafar has clearly stated in his confessional statement that his wife Ansari Khatoon was involved in this alleged occurrence and she also paid some part of money to the real murderer namely Md. Tausif for committing murder of Nujhat Bano. Further Md. Tausif has also stated in his confessional statement that he took Rs. 60,000/- from Ansari Khatoon for committing

murder of Nujhat Bano and all other witnesses of the case diary have supported the case of the prosecution and investigation is still pending against the petitioners. Further from record it appears that accused petitioners have been involved in the murder of Nujhat Bano.

So, having consideration the above facts and circumstances of this case, I am not inclined to enlarge the above named accused petitioners on the bail at this stage. Accordingly, bail petition filed on behalf of the accused persons namely Ansari Khatoon and Md. Zabar @ Zafar namely, are hereby rejected.
