**ORDER**

An anticipatory bail petition has been filed on behalf of the accused petitioner namely Rajdev Singh, who is apprehending his arrest in connection with Kursela P.S. Case No. 3/2026 for the offences registered U/S 103(1), 61(2)/3(5) of BNS and 27 Arms Act. The copy of the same has been duly served to the Ld. Addl. P.P. for the State.

The Ld. counsel of the petitioner has submitted that no B.P. or A.B.P. on behalf of the accused petitioner has been filed or moved before this court or before the Hon'ble High Court, Patna. The petitioner has no other criminal antecedents. The petitioner has been falsely implicated in this case due to village politics and nothing has been recovered from his possession. The petitioner was not present at the place of occurrence at the time of incident. The petitioner is ready to furnish local and sound bailors for the court satisfaction. Accordingly, prayed to grant bail.

On the other hand, the Ld. Addl. P.P. opposed the prayer of A.B.P. filed on behalf of the above named accused petitioner and submitted that the petitioner has committed the alleged offence under well planned manner. Hence, it is requested to reject the petition of the above named accused petitioner.

The case of the prosecution, in brief, is that the informant Poonam Jha stated that her son had been under stress for the past few days due to repeated death threats from six named accused persons. On 01.01.2026 at about 5:45 PM, she received information that her son was shot near Kursela Chowk in front of Gupta Hotel. She believes that the named accused persons were responsible for the shooting. Hence, the present case.

Heard rival submission of the Ld. counsel on behalf of the accused petitioners and the Ld. Addl. P.P. for the State and perused the L.C.R. The present Kursela P.S. Case No. 3/2026 has been registered U/S 103(1), 61(2), 3(5) of BNS. against the accused petitioner. Although, the petitioner has no criminal antecedents, but he is the named accused of the FIR and there is allegation against him that he was continuously giving threat to the deceased Sagar Jha and later on, 01.01.2026 someone has shot him dead in front of Gupta Hotel at

Kursela Chowk. Investigation is going on against the petitioner. The allegations are serious in nature and there are enough chance of absconding.

Hence, considering the aforesaid facts and circumstances and discussions made herein above and keeping in mind the seriousness of accusation and gravity of offences, I am not inclined to enlarge the petitioner on bail. Accordingly, prayer for bail of the above named accused petitioner stands **rejected**.
