ORDER

03.06.2026- This anticipatory bail petition has been filed on the behalf of petitioners namely **1. Md. Jubedul, 2. Jaherul, 3. Sajma Khatoon, and 4. Parweena Khatoon** who are apprehending their arrest in connection with aforesaid case.

Heard the Ld. counsel Shri Md. Mansoor Alam appearing on the behalf of the petitioners and Ld. A.P.P. Shri Md. Azaj Alam on the behalf of the state.

According to F.I.R. prosecution case in nutshell is that informant to this case namely Sahabuddin lodged a written report before S.H.O. Kachna alleging therein that on alleged date and time of occurrence accused-petitioners namely 1. Md. Jubedul, 2. Jaherul, 3. Sajma Khatoon, 4. Parweenaa Khatoon and other accused named in F.I.R. were assaulting to the Rabida Khatoon having laced with weapons. When he went there to rescue her then aforesaid accused persons started assaulting to him. Accused namely Jamshed abused to the informant and told that informant has sold the land and ordered to kill to the informant then Jubedal gave a blow of sword at the head of informant due to which his head got injured and being injured he fell down. Later on, villagers arrived there and saved to the informant.

On the other side learned counsel for the petitioners has reiterated all the grounds taken in the bail petition and has submitted that the petitioners are innocent and have committed no offence at all and they have falsely been implicated in this case. He has further submitted that the petitioner Jubedul filed a case against the informant of this case Sahabuddin and others vide Kachna P.S. case no. 08/2026 earlier to this case and this case has been brought home with a view to save skin of the informant due to that petitioner has filed a case before. Accused-petitioners have got no criminal antecedent. Accordingly, it has been prayed to allow the said anticipatory bail petition.

Per contra, Learned A.P.P. has vehemently opposed the prayer for anticipatory bail.

Heard the both parties and perused the record from perusal of the case record

it is evident that there is no specific allegation against the rest three accused persons namely Jaherul, Sajma Khatoon and Parweenaa Khatoon except to participating in this alleged occurrence. Though there is specific allegation against the accused-petitioner namely Jubedul that he gave a blow of sword at the head of informant due to which he got injured but injury sustained by informant has been reported to be simple in nature and from record it is evident that there is land dispute between the both parties and as per bail petition petitioners have got no criminal antecedent.

So having considered the above facts and submissions made by the Ld. Counsel for the petitioners, the instant anticipatory bail petition is hereby allowed and accordingly it is ordered to release the petitioners namely **1. Md. Jubedul, 2. Jaherul, 3. Sajma Khatoon, and 4. Parweena Khatoon** on bail in the case of surrender/arrest within three weeks of this order on furnishing of bail bond of Rs. 10,000/- with two sureties of the like amount each to the satisfaction of the learned court concerned subject to the condition as mentioned in the section 482 (2) of the B.N.S.S..
