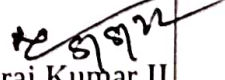

Bail petition dated 02.08.22 filed on behalf of the accused in custody Taroni Rai @ Tarani Rai, aged about 34 years, s/o Late Satish Rai, r/o Kuram, PS Balia Belon, District Katihar is conducted today. Case called out. Heard both the sides.</li> <li>2. The learned counsel appearing on behalf of the petitioner submitted that no BP or ABP had been filed earlier in this court or any superior court. It was further submitted that the charge had already been leveled against this petitioner on 21.01.2013. It was further submitted that the petitioner left to do pairvee due to miscommunication and his bail bond was canceled on 29.07.2015. It was further submitted that the accused surrendered before the court on 23.07.2022. It was further submitted that the accused/petitioner had been in custody since 23.07.2022. It was submitted that the petitioner was ready to furnish the solvent bailors, if he be enlarged on bail. The learned counsel prayed to enlarge the petitioner on bail.</li> <li>3. The learned <del>Spl. P.P.</del> <u>APP</u> opposed the bail petition and prayed to reject it.</li> <li>4. Perused the case record. It was submitted that due to wrong miscommunication made by his clerk, the petitioner was under impression that his case was disposed, but in fact the case was continued and his bail bond was canceled on 29.07.2015. The petitioner has been in custody since 23.07.2015.</li> <li>5.
